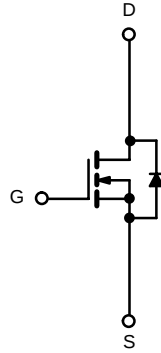

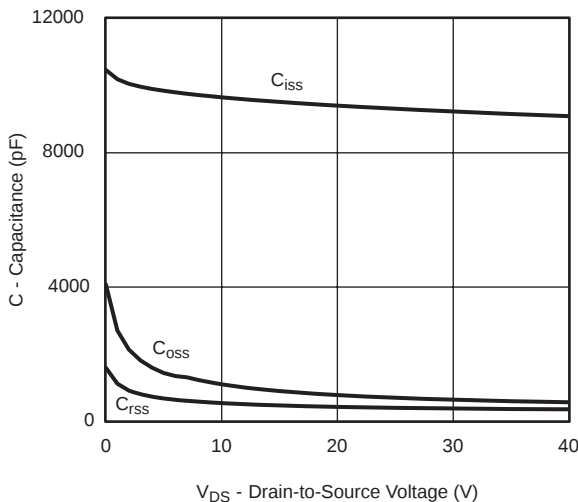

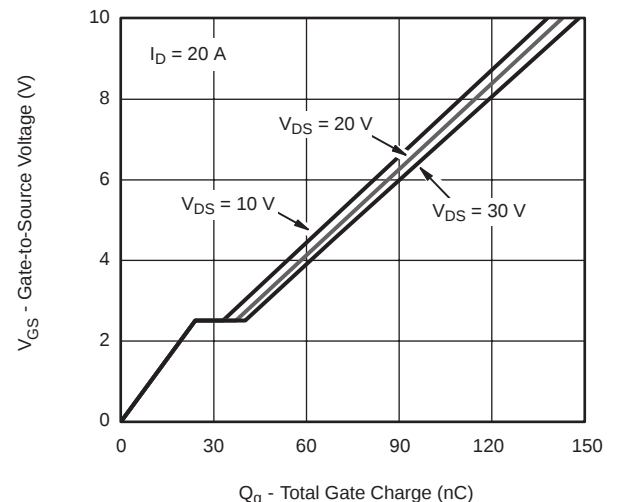
Transconductance

Capacitance

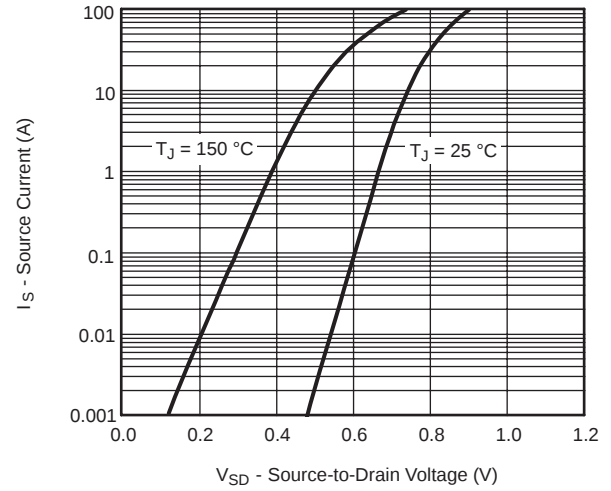

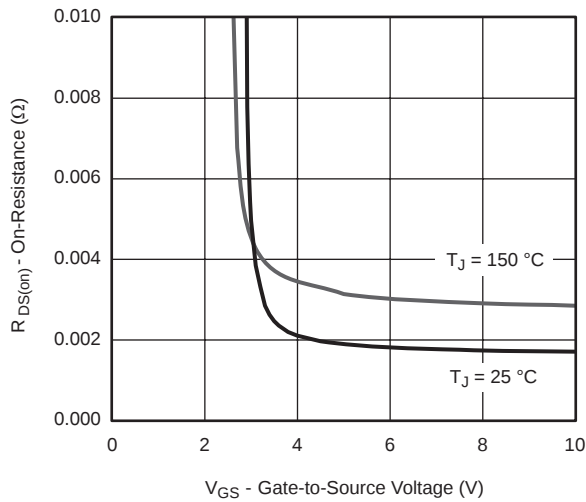

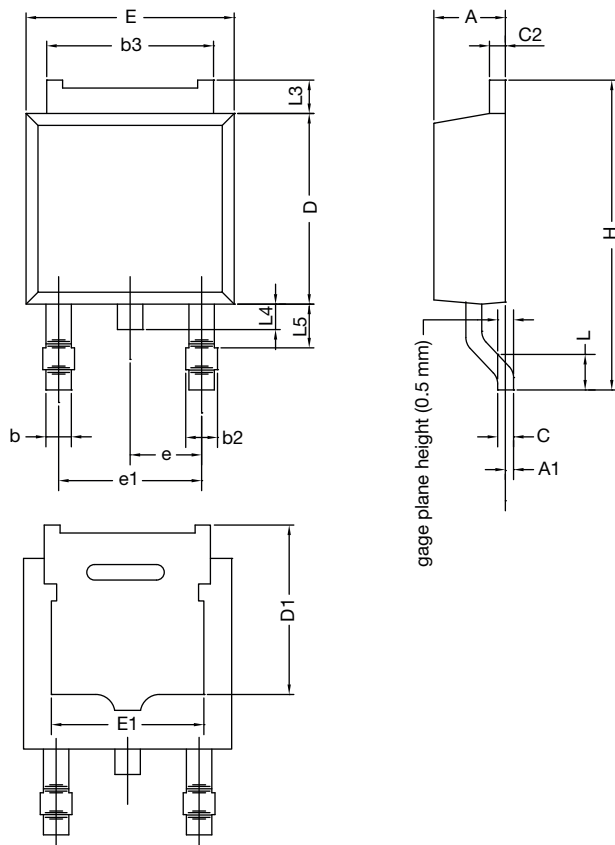
