5-LEAD TSOP

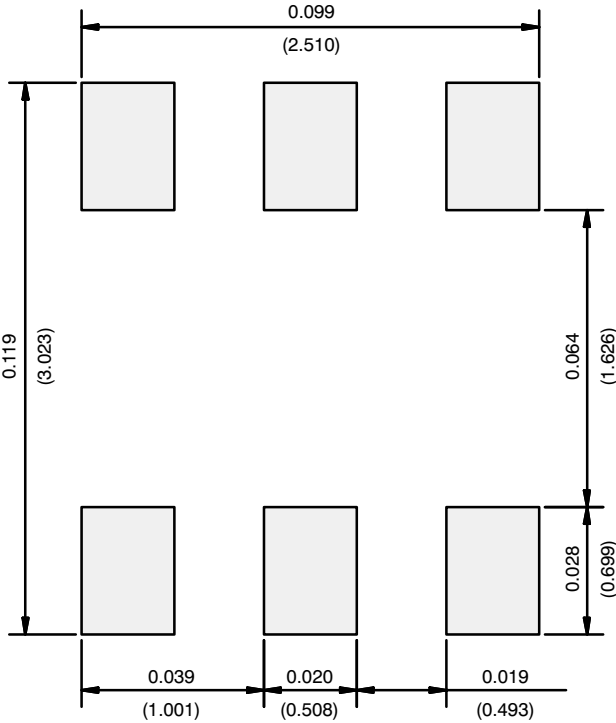
