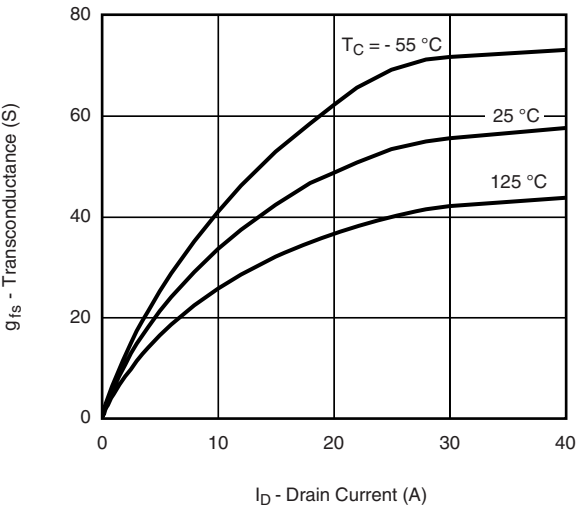

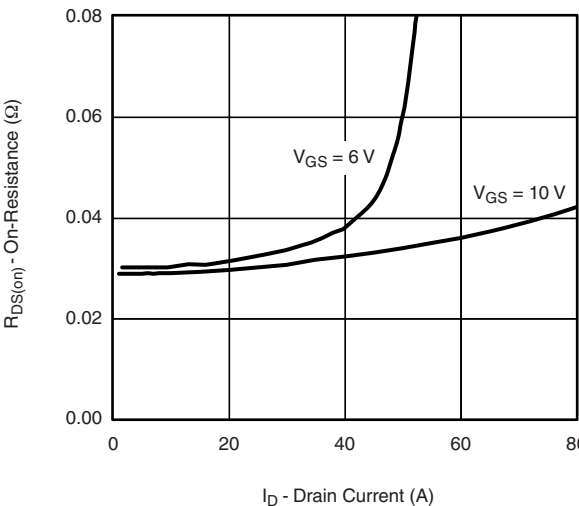

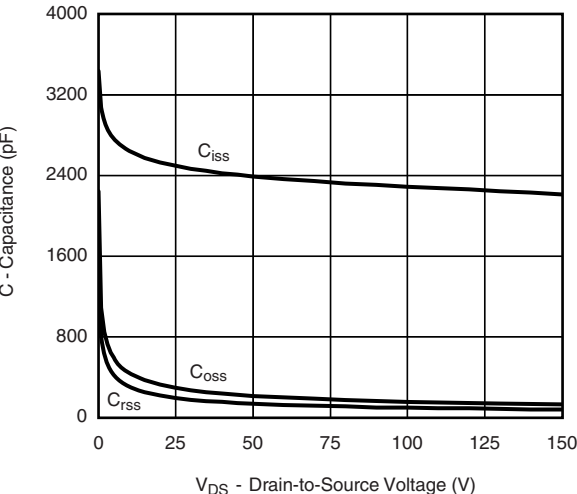

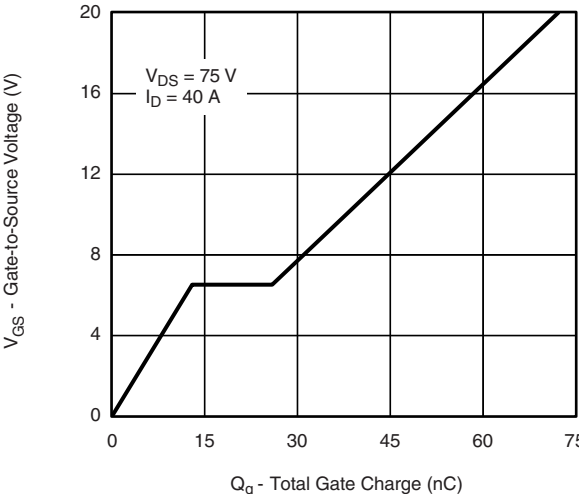

On-Resistance vs. Drain Current

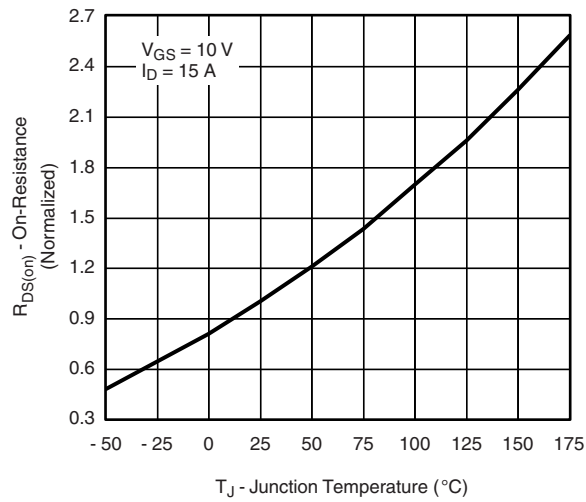

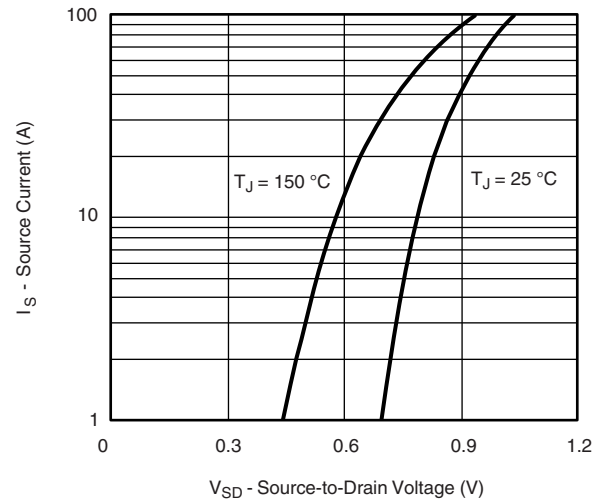

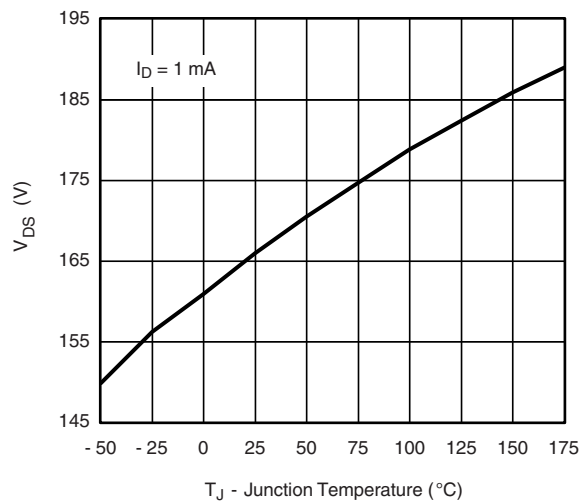

On-Resistance vs. Junction Temperature

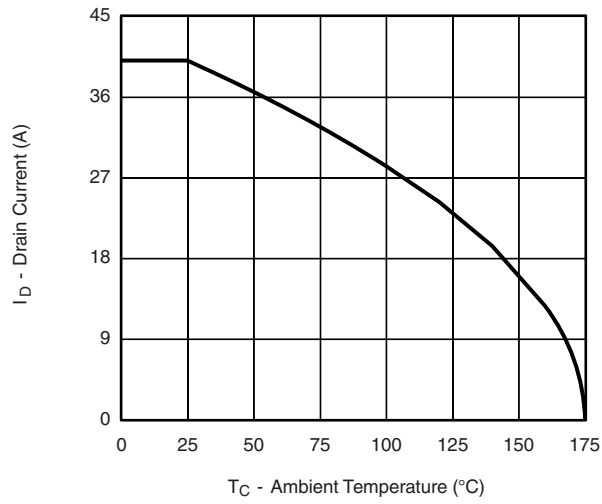


Source-Drain Diode Forward Voltage

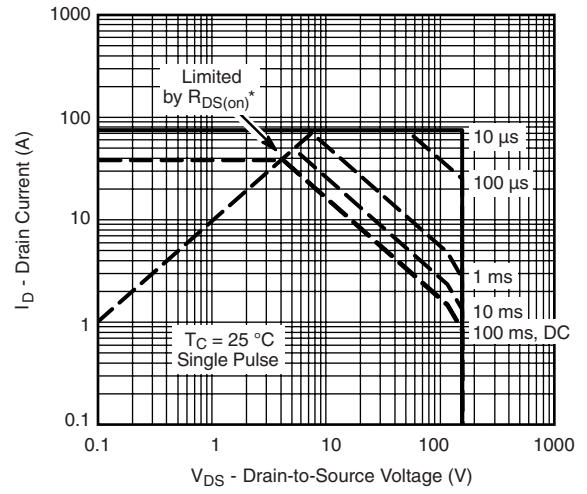


Drain Source Breakdown vs. Junction Temperature

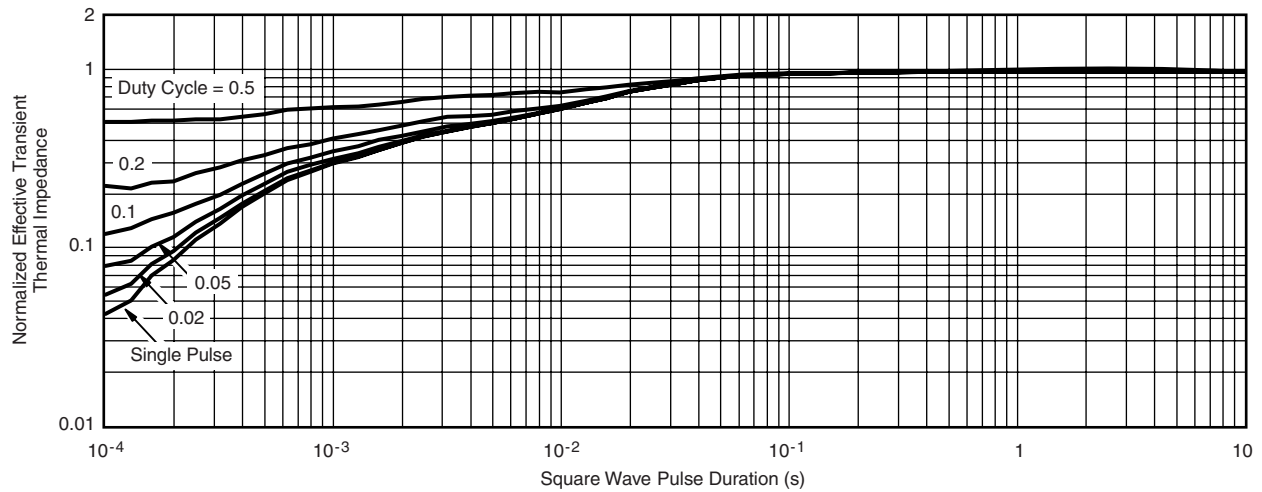


**Maximum Avalanche and Drain Current
vs. Case Temperature**



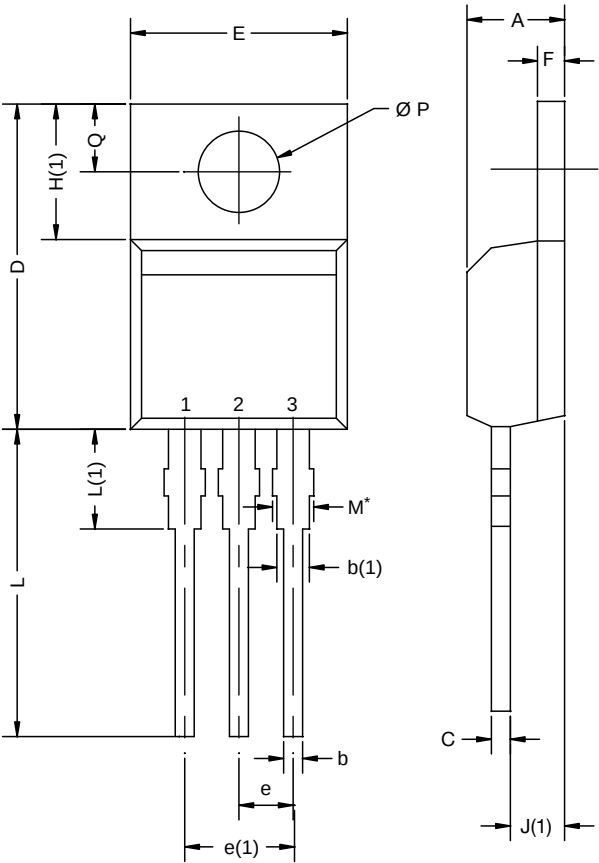
