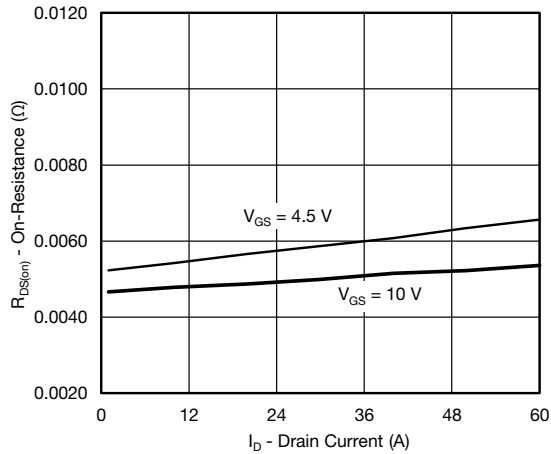

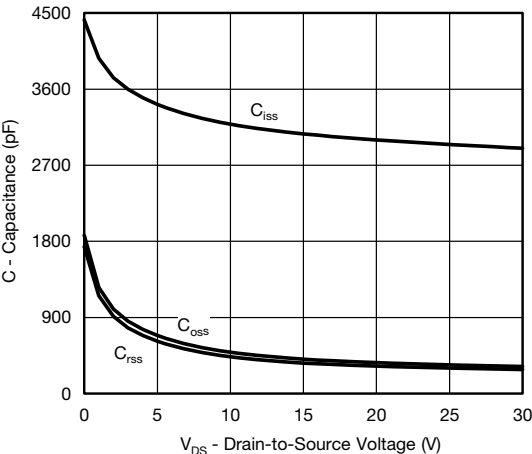

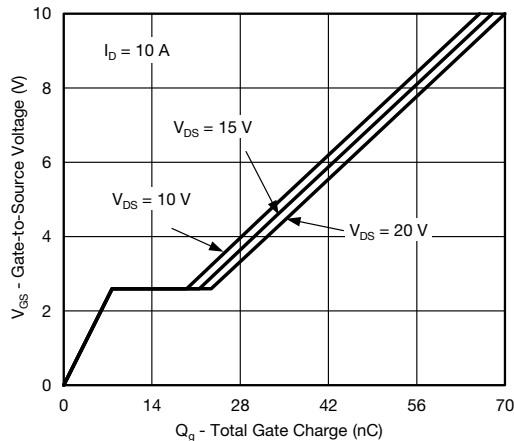
Transfer Characteristics



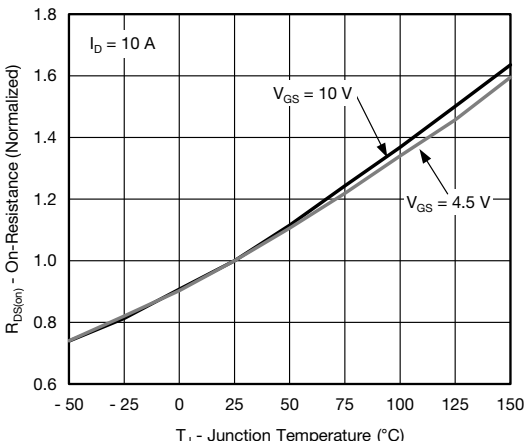
On-Resistance vs. Drain Current and Gate Voltage



Capacitance

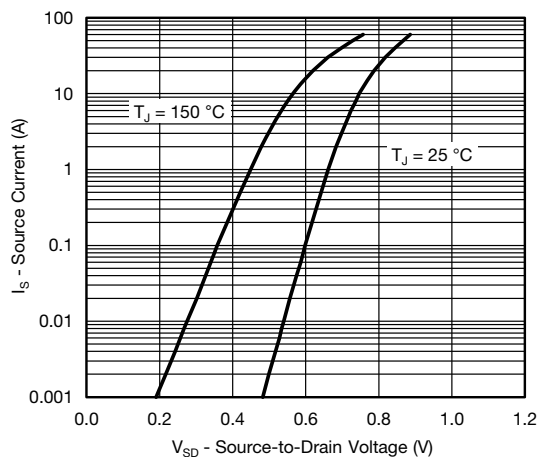


Gate Charge

Threshold Voltage



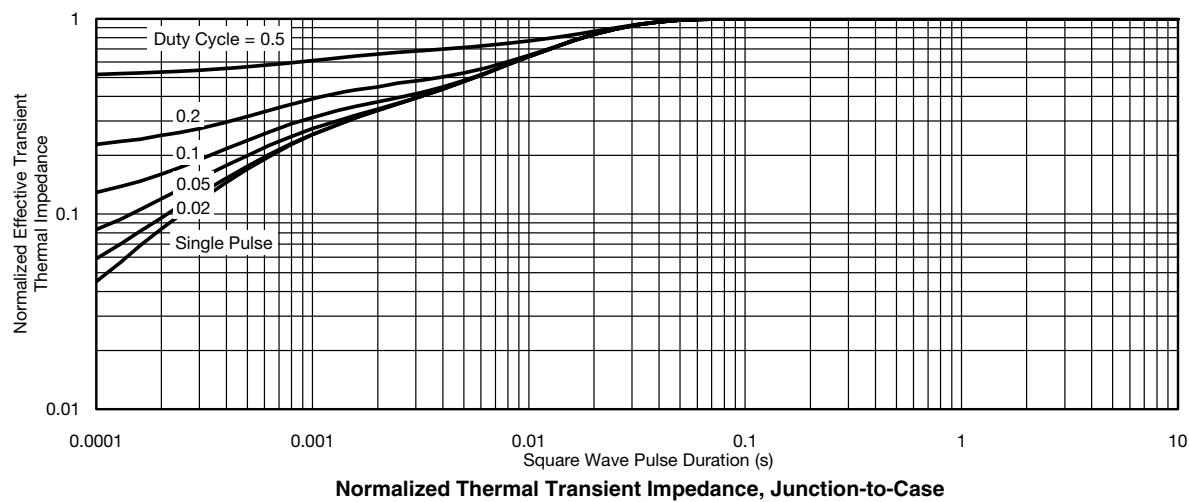

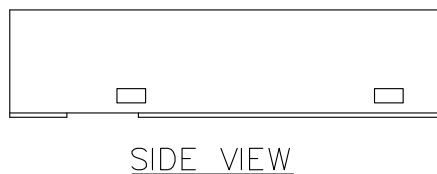
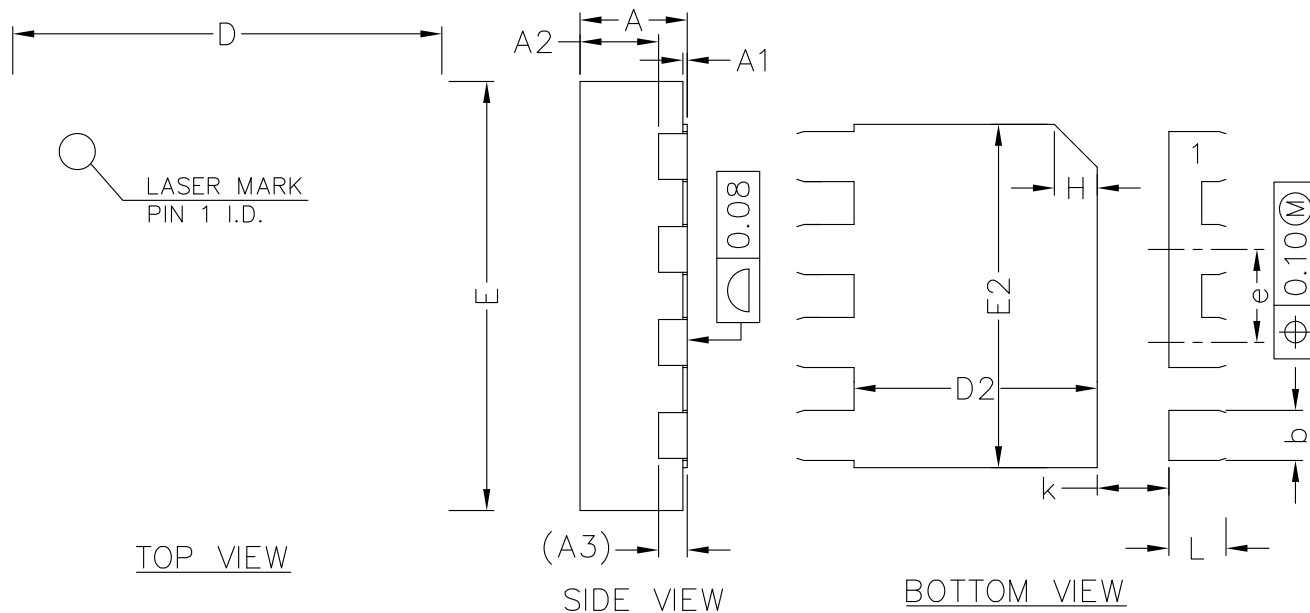


Safe Operating Area, Junction-to-Ambient
