

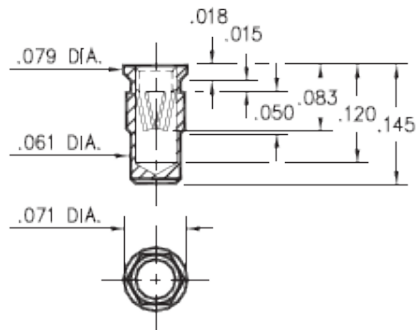

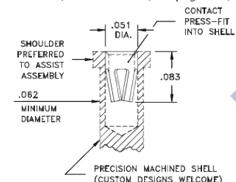

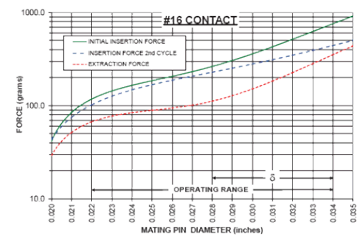

BRASS ALLOY (UNS C36000) per ASTM B 16
