



### Properties of BRASS ALLOY 360 ASTM B 16:

- Chemical composition: Cu 63% (max), Pb 3.7% (max)†, Fe .35% (max), Zn remainder
- Temper as machined: H02/H04
- Yield Strength: 25-45 ksi
- Tensile strength: 57-80 ksi
- Hardness as machined: 80-90 Rockwell B
- Electrical conductivity: 26% IACS\*
- Melting point: 1000°C/840°C (liquidus/solidus)

### Properties of BRASS ALLOY 385 ASTM B 455:

After machining, brass parts are often annealed (softened) for subsequent bending, swaging or crimping. A partial anneal down to  $60\pm 10$  RB is recommended for 90° bends, a full anneal down to  $35\pm 15$  RB is recommended for pins or terminals that are swaged (riveted) to a circuit board or crimped to a wire.
