

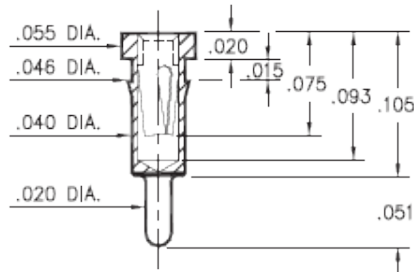

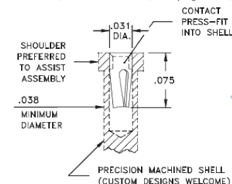

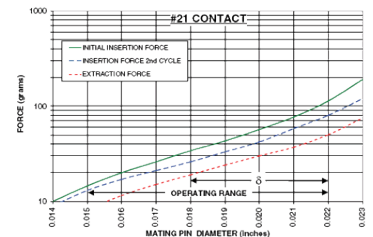

Phosphor Bronze (UNS C54400) per ASTM B 139

- Used for pins requiring more durability than Brass.
