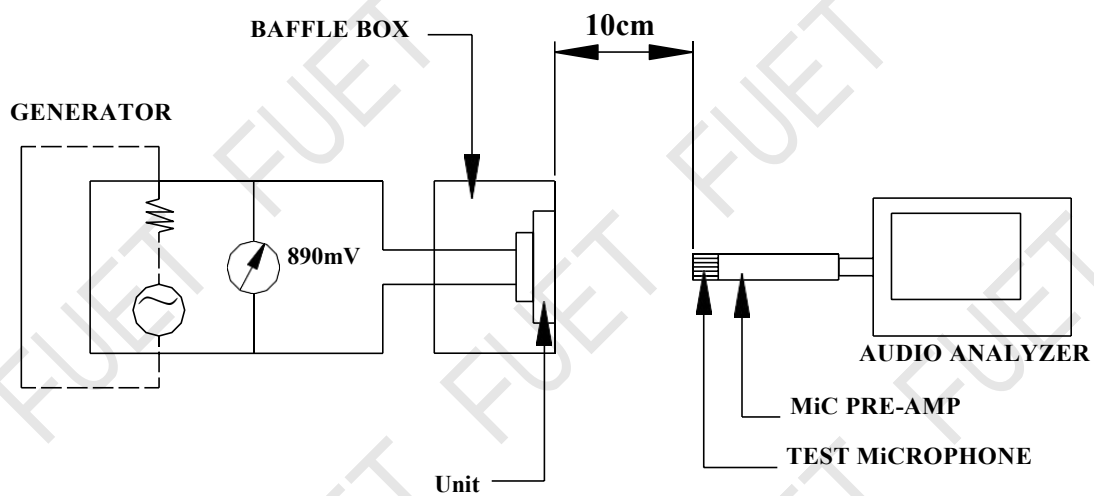
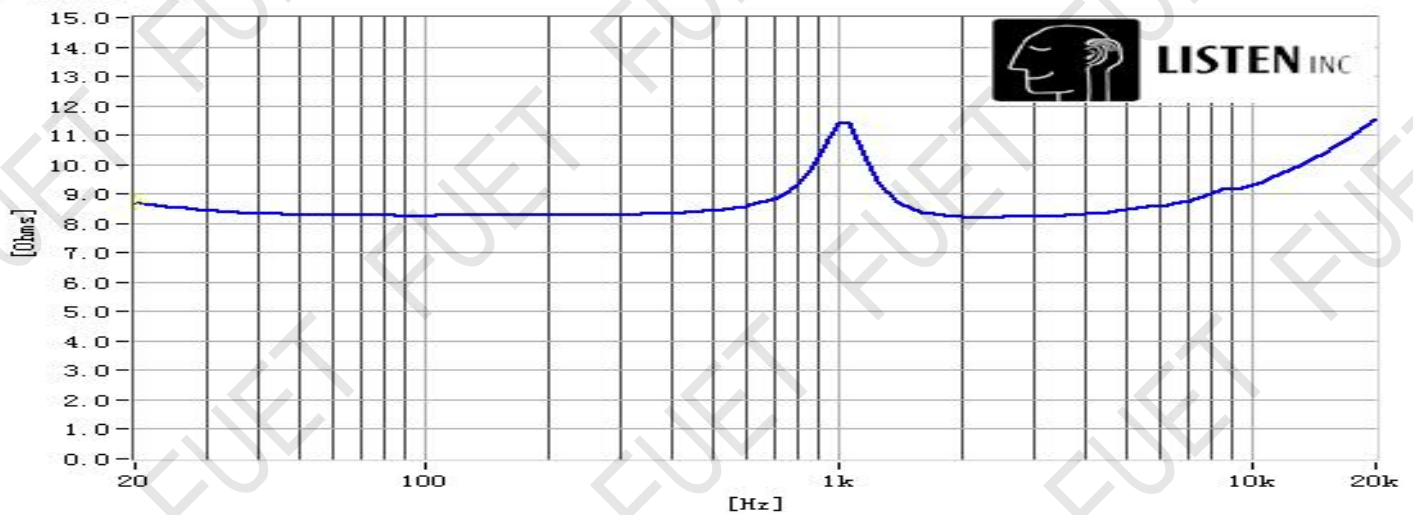


Frequency Response

频响曲线

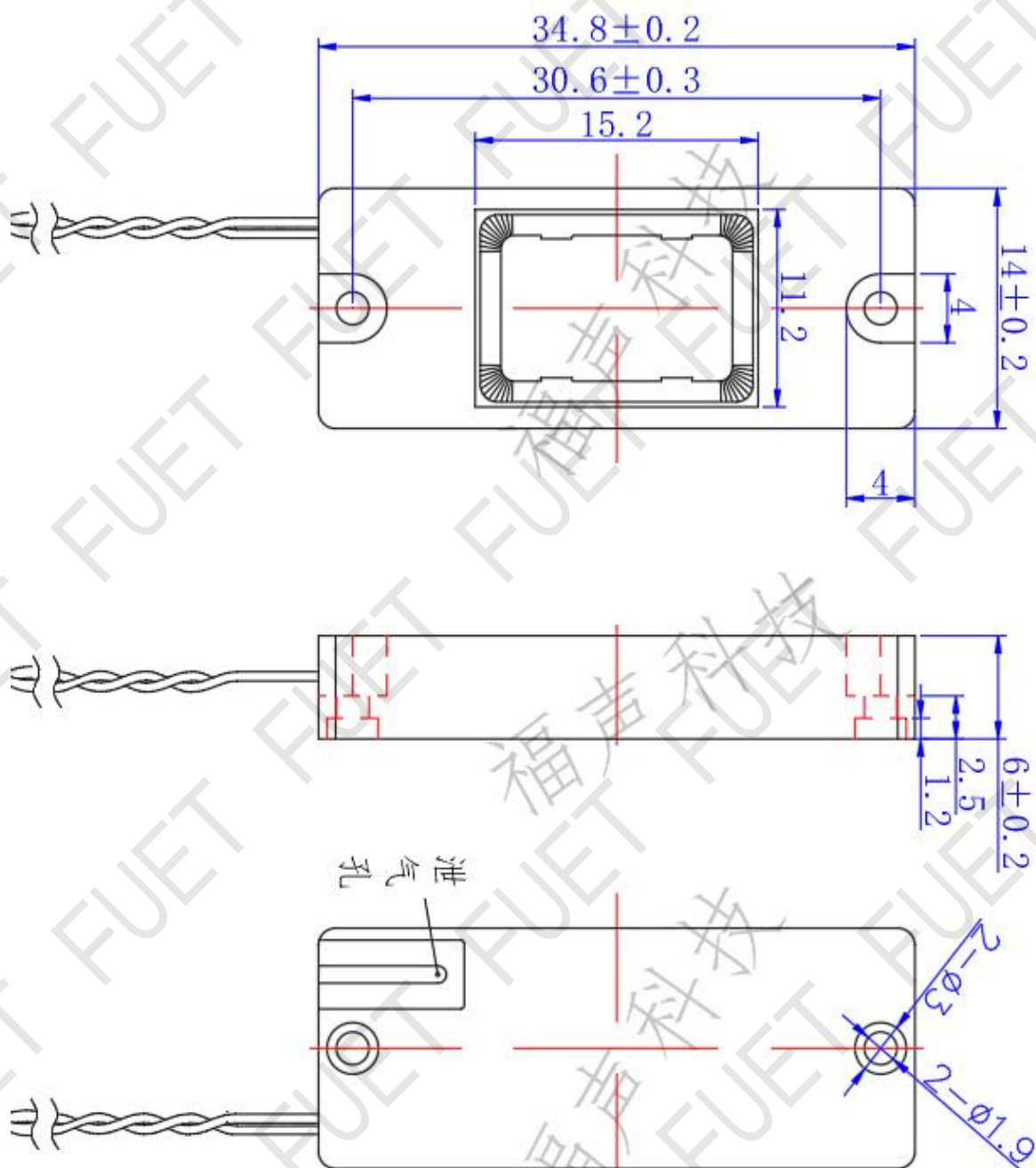


阻抗曲线
