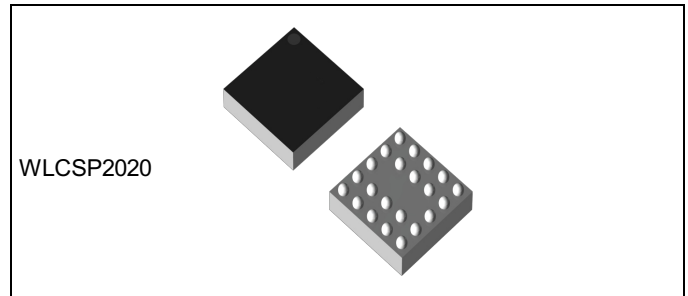

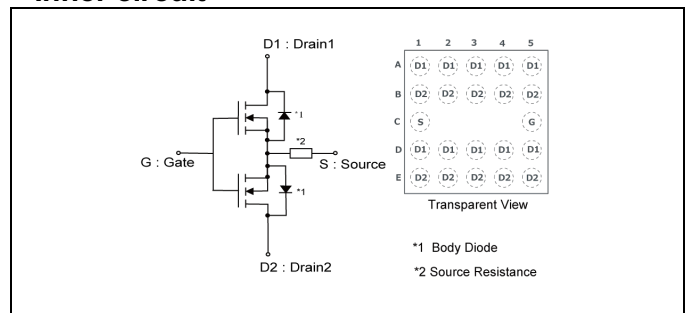

Fig.1 Power Dissipation Derating Curve

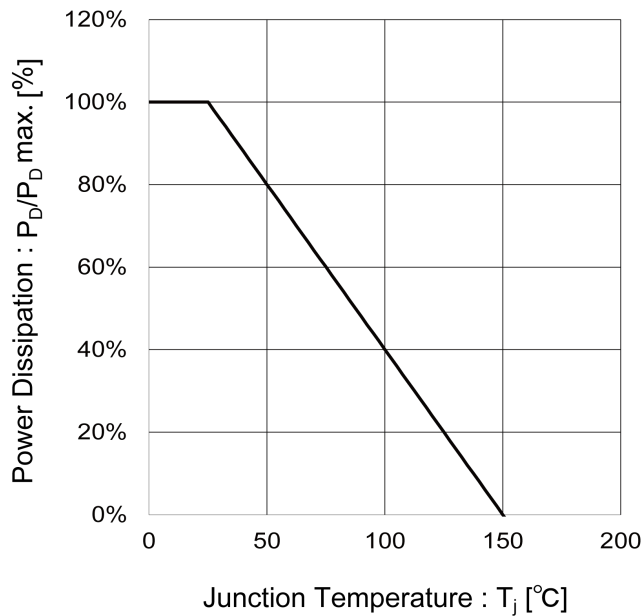


Fig.2 Maximum Safe Operating Area

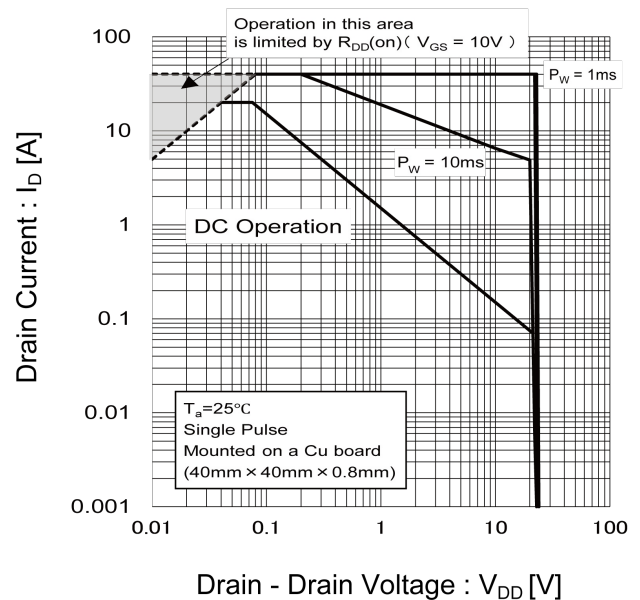
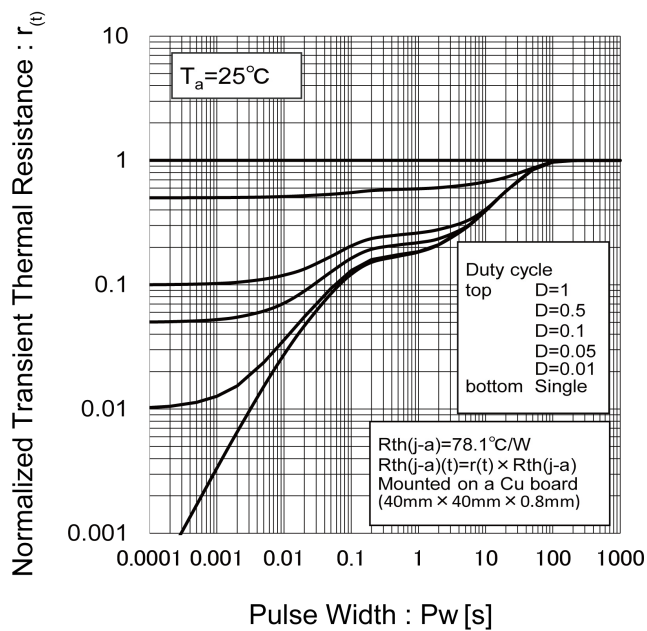


Fig.3 Normalized Transient Thermal Resistance vs. Pulse Width

Fig.4 Typical Output Characteristics(I)

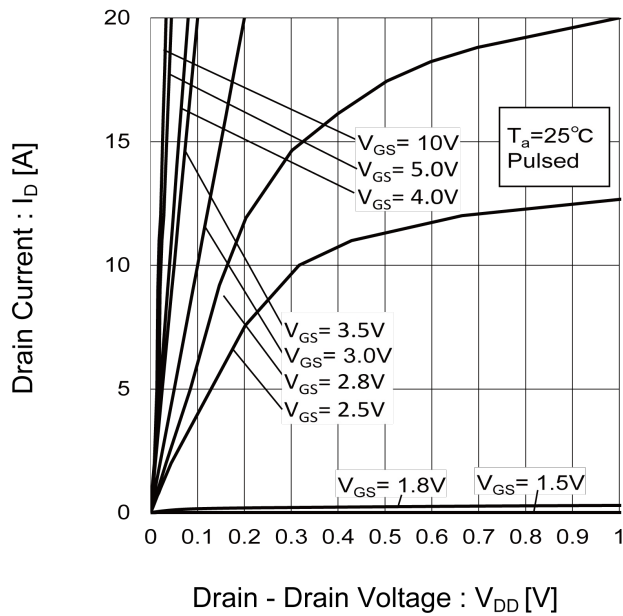


Fig.5 Typical Output Characteristics(II)

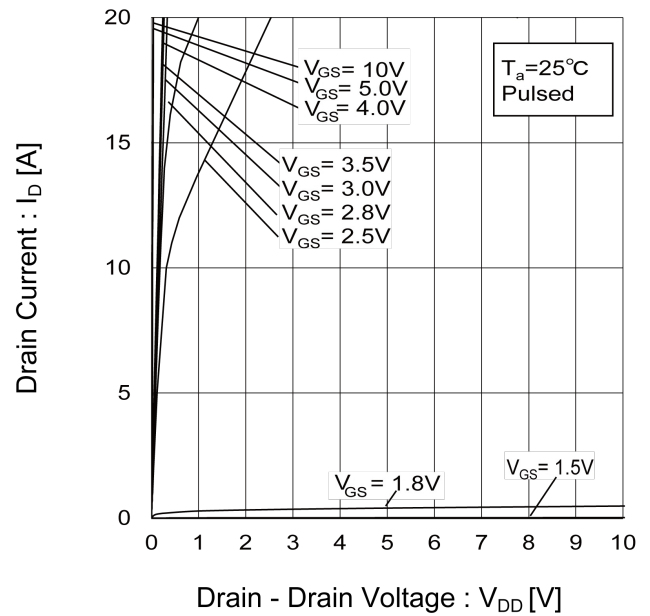


Fig.6 Typical Transfer Characteristics

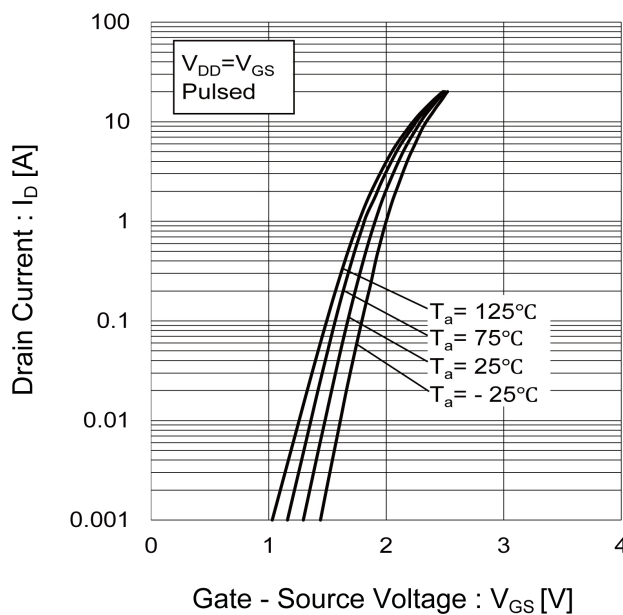
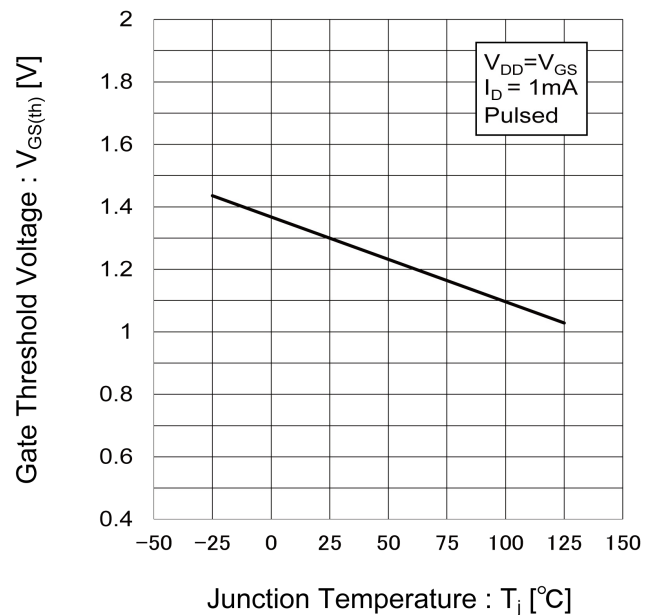


Fig.7 Gate Threshold Voltage vs. Junction Temperature

Fig.8 Drain Current Derating Curve

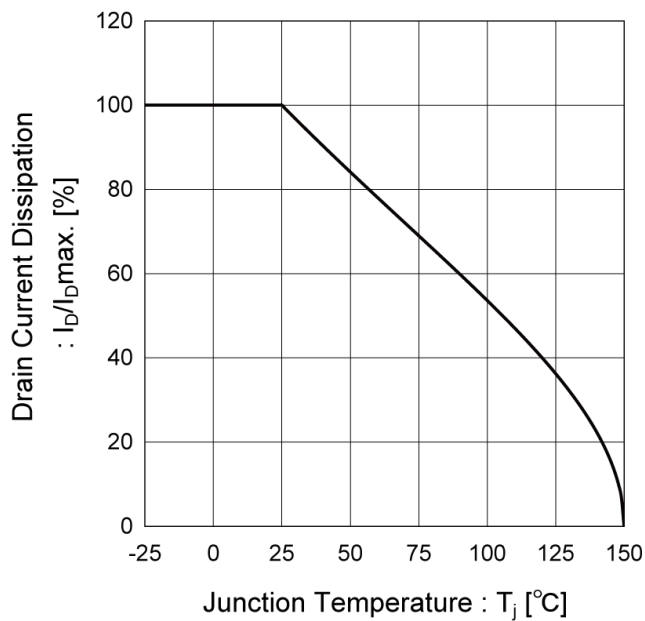


Fig.9 Static Drain - Drain On - State Resistance vs. Gate Source Voltage

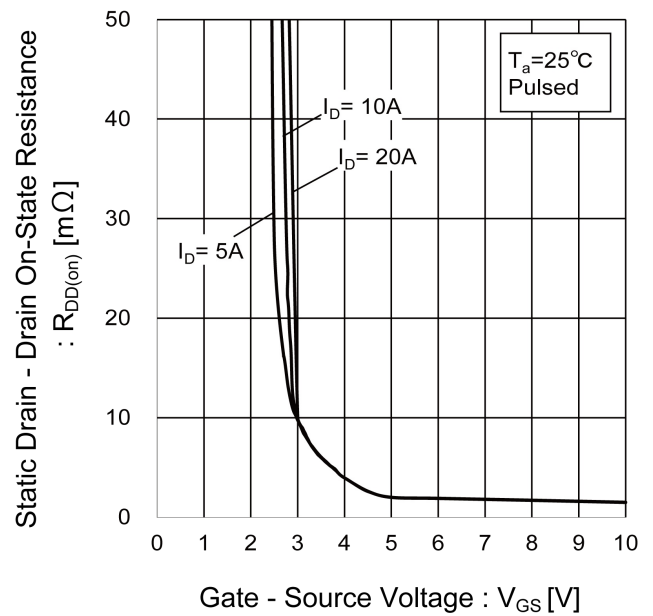


Fig.10 Static Drain - Drain On - State Resistance vs. Drain Current (I)

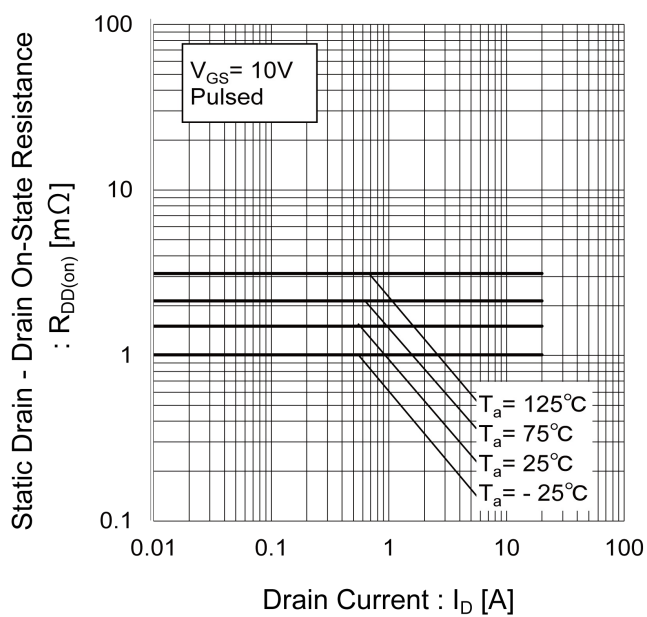
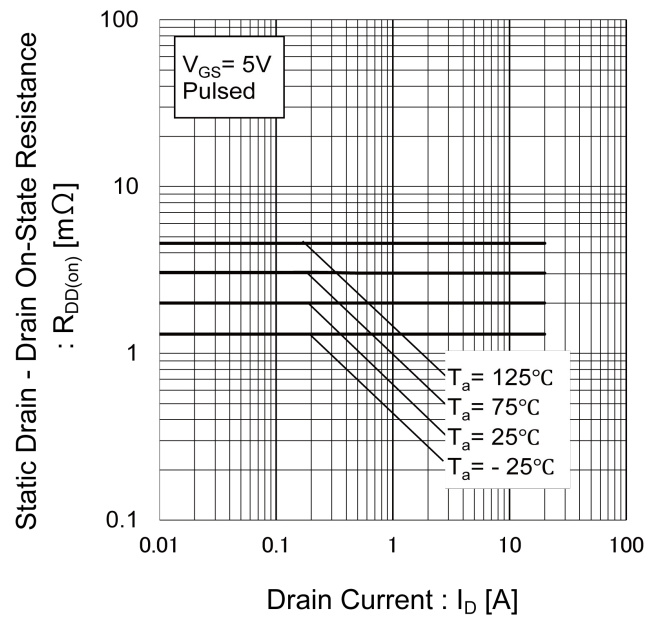


Fig.11 Static Drain - Drain On - State Resistance vs. Drain Current (II)

Drain - Source Voltage

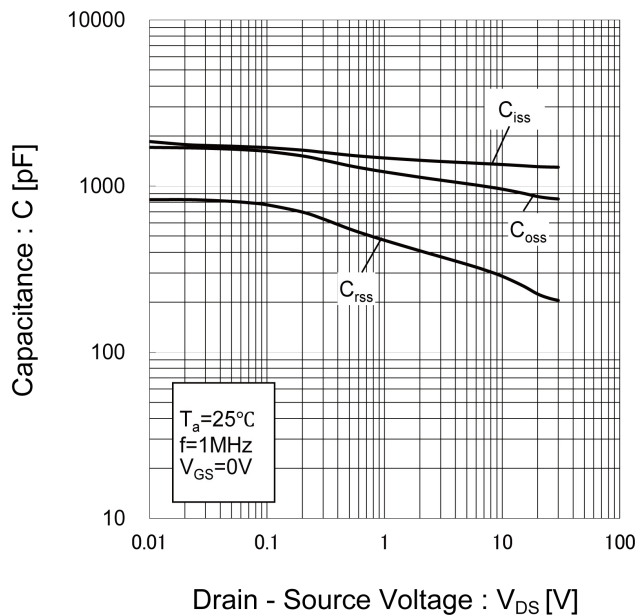


Fig.13 Switching Characteristics

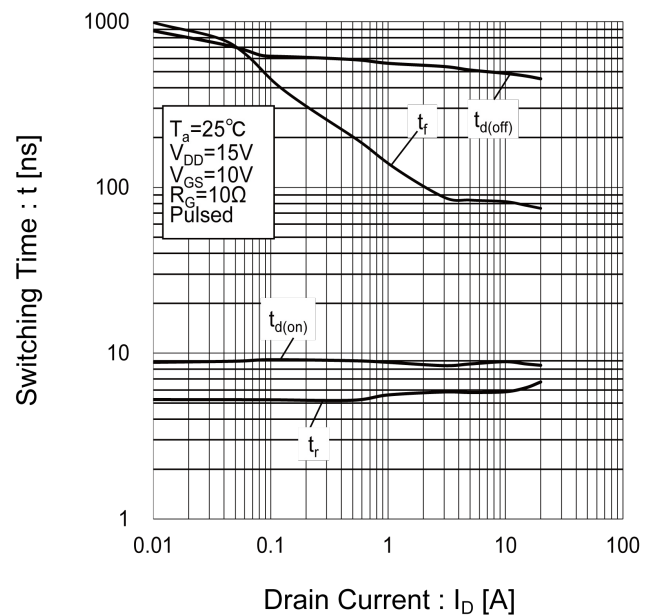
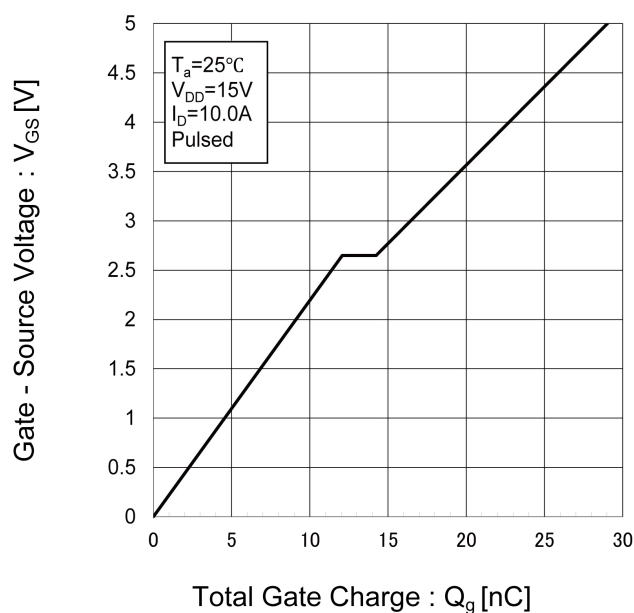


Fig.14 Dynamic Input Characteristics

Fig. 1-1 SWITCHING TIME MEASUREMENT CIRCUIT

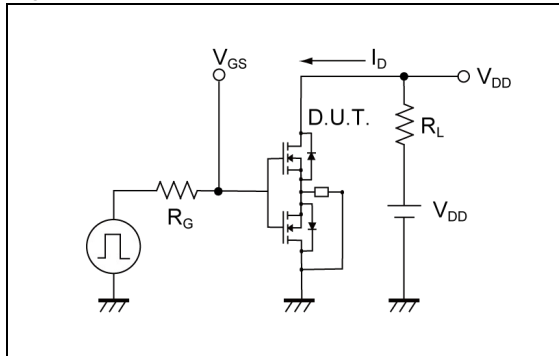


Fig. 1-2 SWITCHING WAVEFORMS

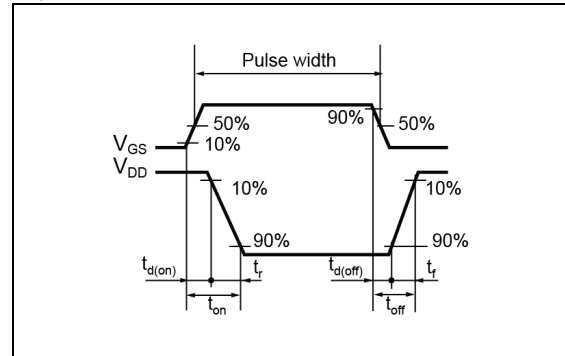


Fig. 2-1 GATE CHARGE MEASUREMENT CIRCUIT

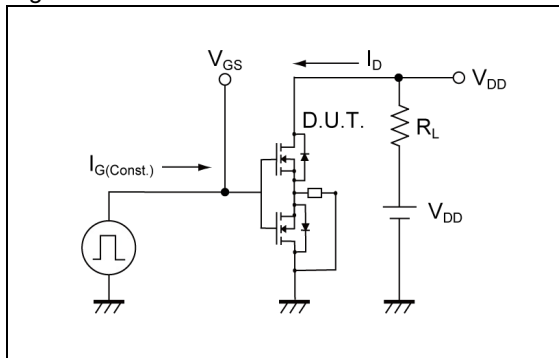
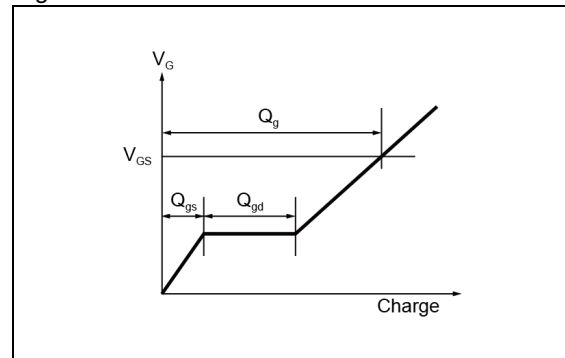


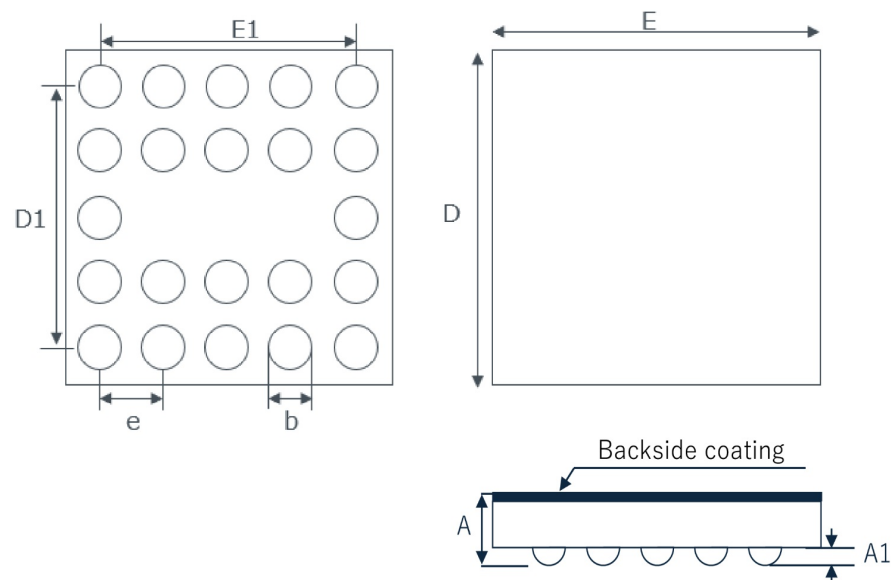
Fig. 2-2 GATE CHARGE WAVEFORM
