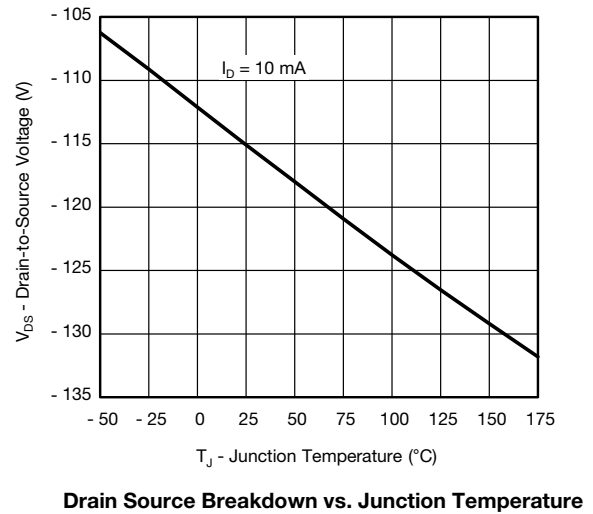
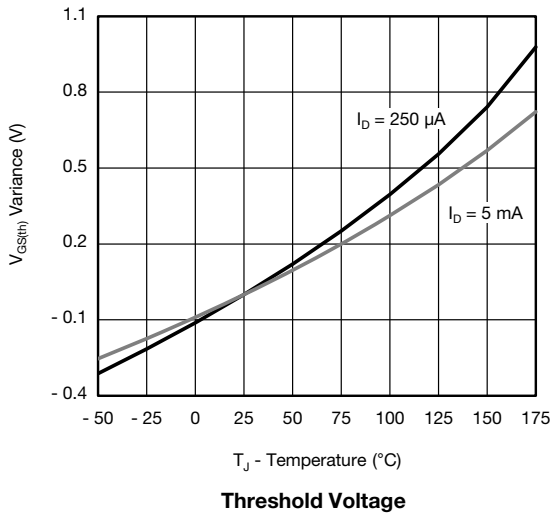
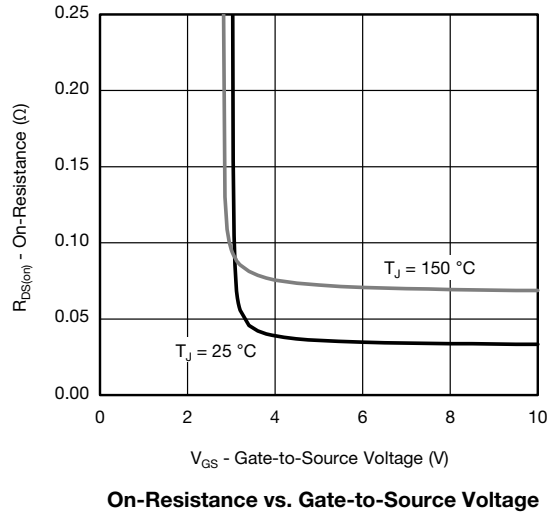
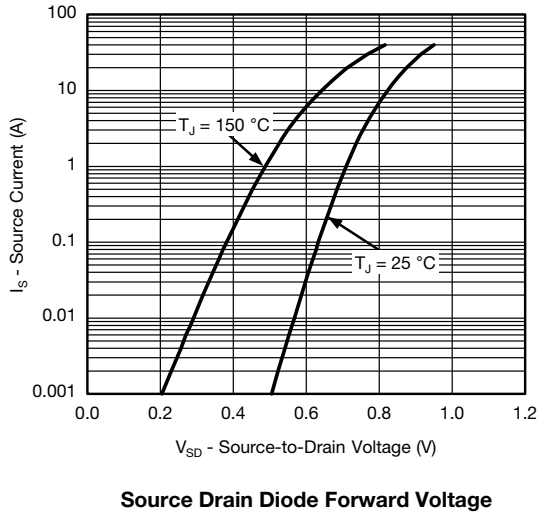
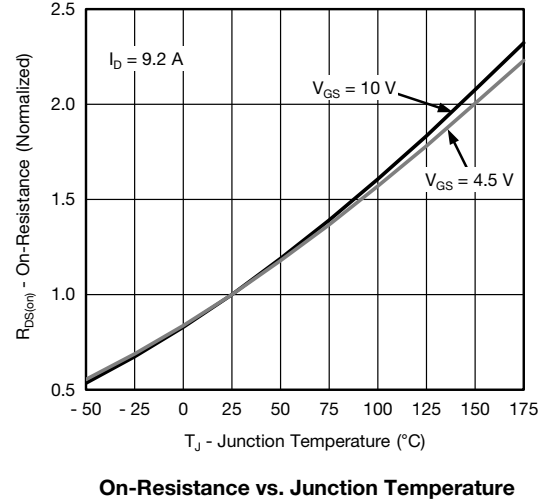
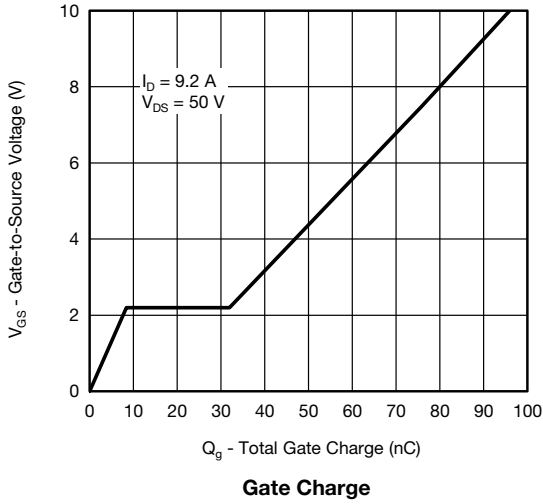


**On-Resistance vs. Drain Current**

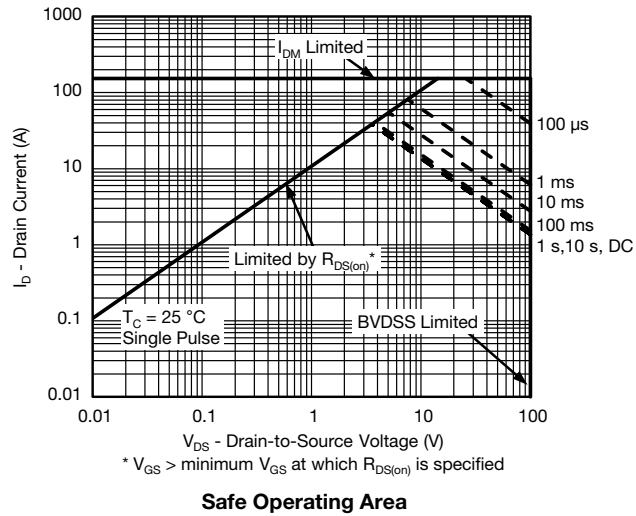

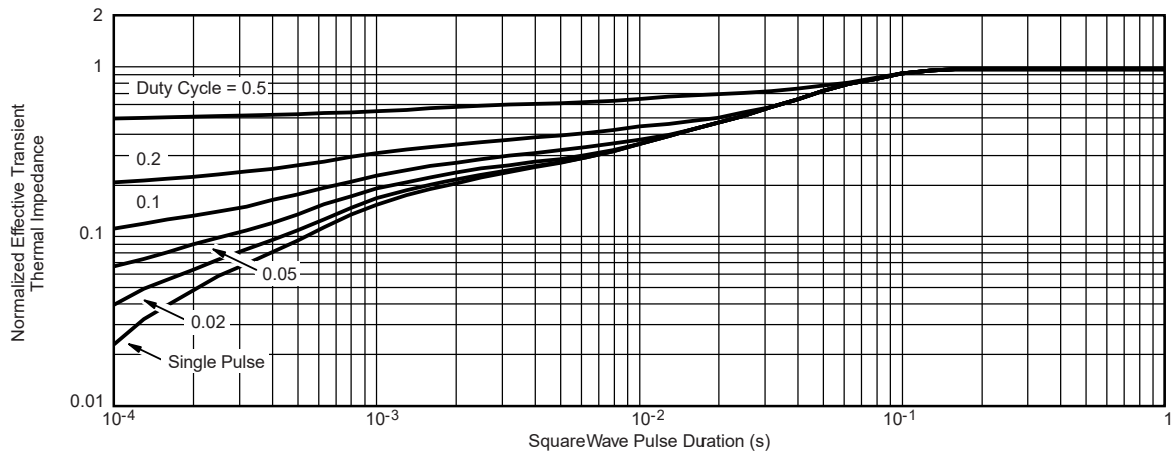

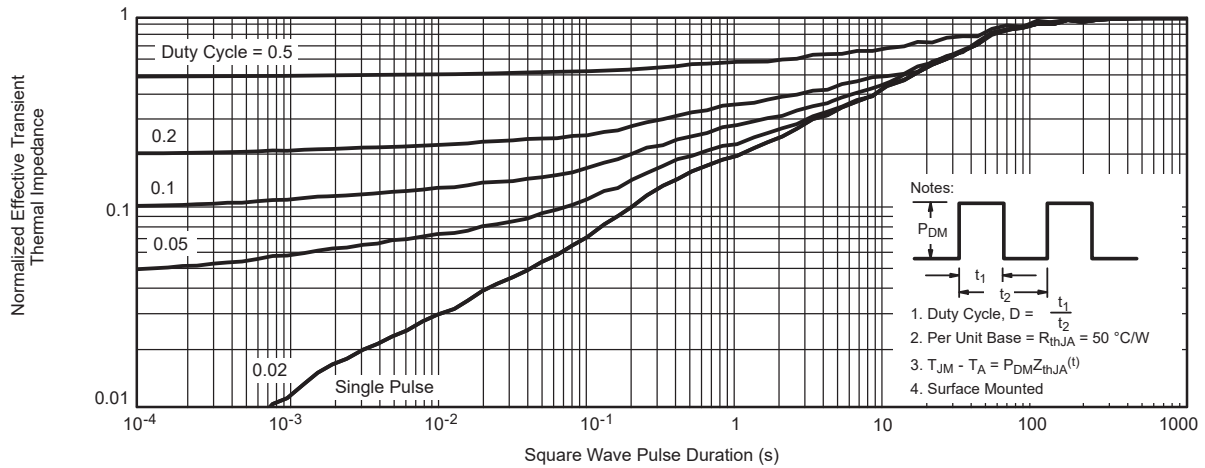


**Safe Operating Area**

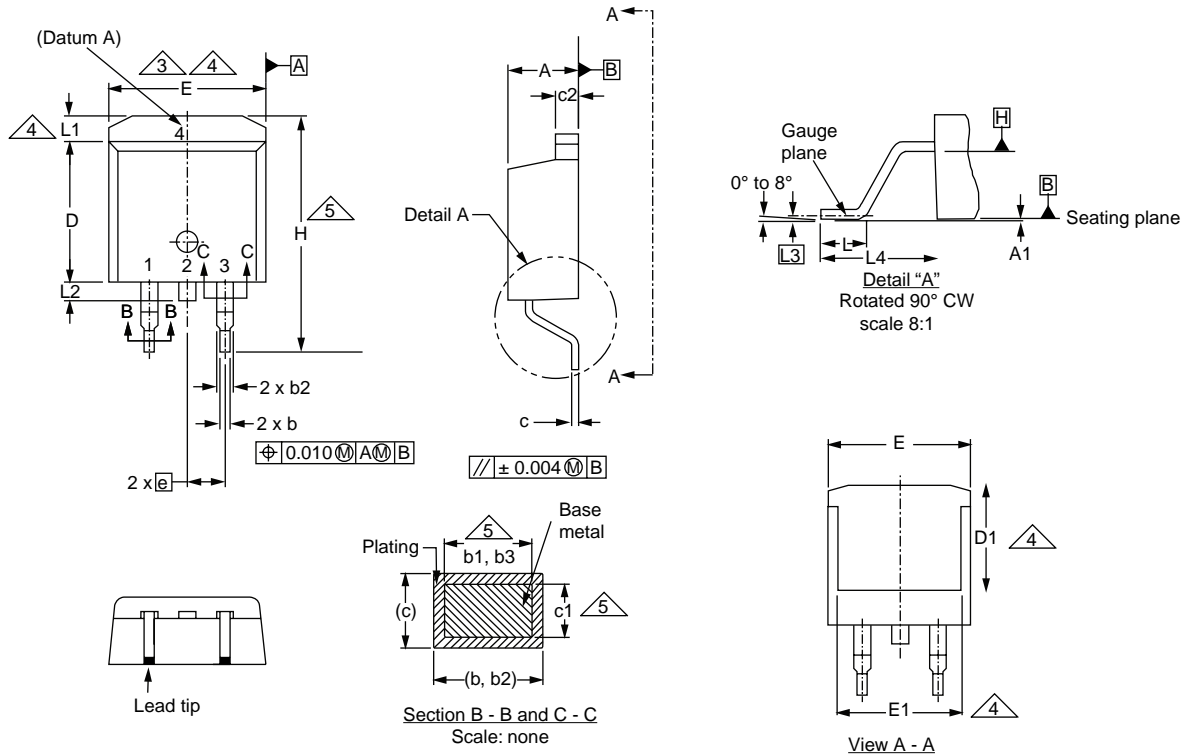


**Normalized Thermal Transient Impedance, Junction-to-Ambient**
