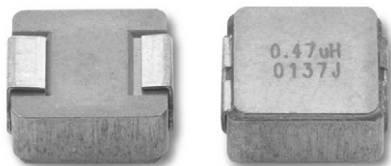

Notes

- All test data is referenced to 25 °C ambient

Circuit design, component placement, PWB trace size and thickness, airflow and other cooling provisions all affect the part temperature. Part temperature should be verified in the end application
- Rated operating voltage (across inductor) = 40 V
- (1) DC current (A) that will cause an approximate ΔT of 40 °C
- (2) DC current (A) that will cause L_0 to drop approximately 20 %

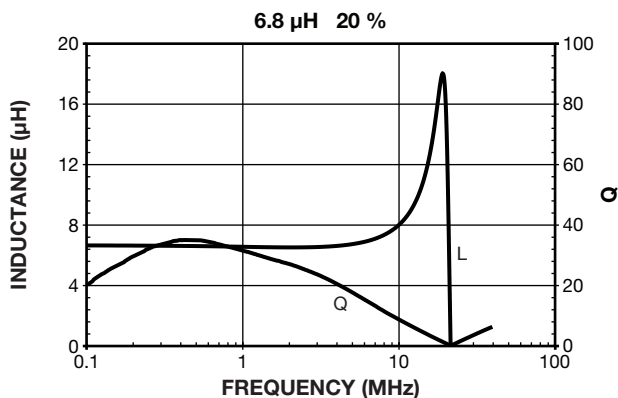
