

High Efficiency, 1.5MHz, 2A Synchronous Step Down Regulator

General Description

The SY8032I is a high efficiency, 1.5MHz synchronous step down DC/DC regulator capable of delivering up to 2A output current. It can operate over a wide input voltage range from 2.7V to 5.5V and integrate main switch and synchronous switch with very low $R_{DS(ON)}$ to minimize the conduction loss.

The low output voltage ripple, the small external inductor and the capacitor sizes are achieved at 1.5MHz switching frequency.

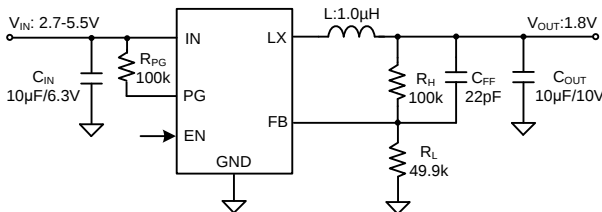


Figure1. Schematic Diagram

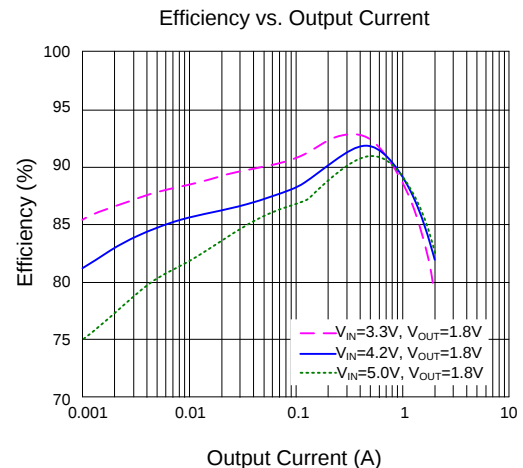
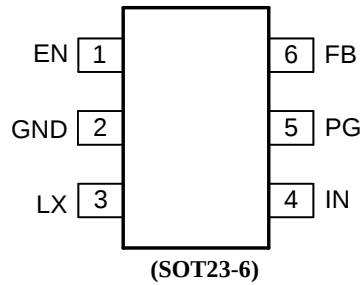


Figure2. Efficiency vs. Output Current

Top Mark: fMxyz (device code: fM, x=year code, y=week code, z= lot number code)

Pin Name	Pin Number	Pin Description
EN	1	Enable control. Pull high to turn on. Do not leave it floating.
GND	2	Ground pin.
LX	3	Inductor pin. Connect this pin to the switching node of the inductor.
IN	4	Input pin. Decouple this pin to the GND pin with at least a 10μF ceramic capacitor.
PG	5	Power good indicator (open-drain output). Low if the output < 90% of the regulation voltage; High otherwise. Connect a pull-up resistor to the input.
FB	6	Output feedback pin. Connect this pin to the center point of the output resistor divider (as shown in Figure 1) to program the output voltage: $V_{OUT}=0.6 \times (1+R_H/R_L)$.

Block Diagram

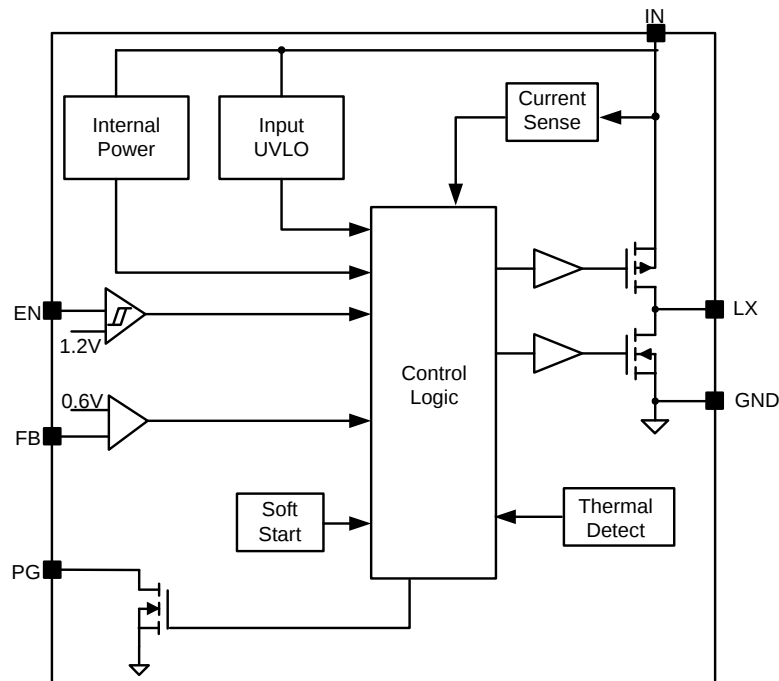


Figure3. Block Diagram

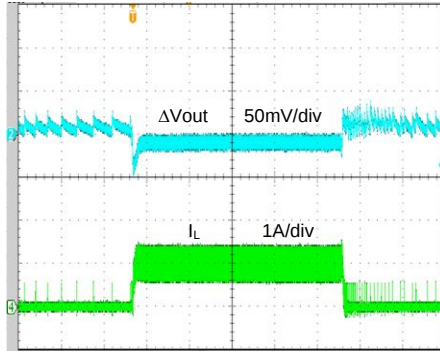

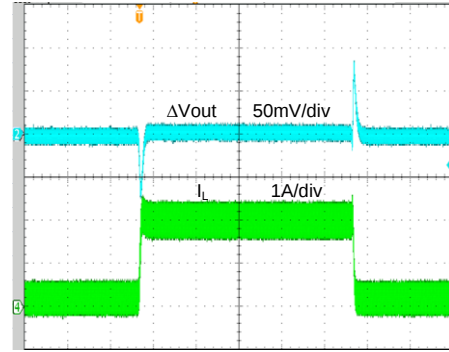


Load Transient
($V_{IN}=5.0V$, $V_{OUT}=1.8V$, $I_{OUT}=0\sim1A$)



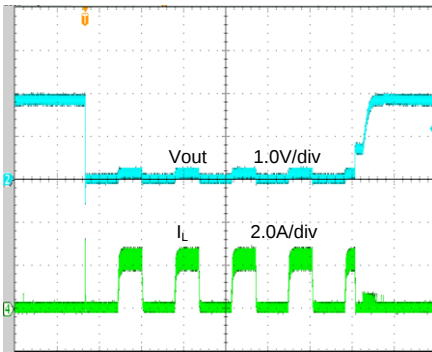
Time (100μs/div)

($V_{IN}=5.0V$, $V_{OUT}=1.8V$, $I_{OUT}=0.2\sim2A$)



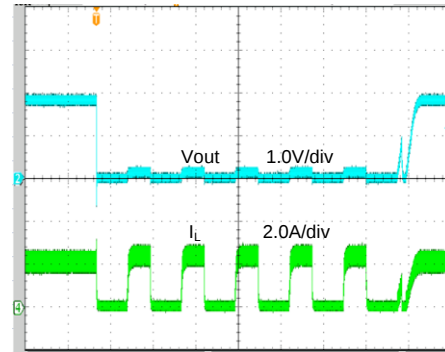
Time (100μs/div)

Operation

The SY8032I is a high efficiency, 1.5MHz synchronous step down DC/DC regulator capable of delivering up to 2A output current. It can operate over a wide input voltage range from 2.7V to 5.5V and integrate main switch and synchronous switch with very low $R_{DS(ON)}$ to minimize the conduction loss.

The low output voltage ripple, the small external inductor and the capacitor sizes are achieved at 1.5MHz switching frequency.

Applications Information

Because of the high integration in the SY8032I, the application circuit based on this regulator is rather simple. Only the input capacitor C_{IN} , the output capacitor C_{OUT} , the output inductor L and the feedback resistors (R_H and R_L) need to be selected for the targeted applications specifications.

Feedback Resistor Dividers R_H and R_L

Choose R_H and R_L to program the proper output voltage. To minimize the power consumption under light loads, it is desirable to choose large resistance values for both R_H and R_L . A value of between 10k and 200k is highly recommended for R_L . If $R_L=100k$ is chosen, then R_H can be calculated to be:

$$R_H = \frac{(V_{OUT} - 0.6V) \cdot R_L}{0.6V}$$

Input Capacitor C_{IN}

A typical X5R or a better grade ceramic capacitor with 6.3V rating and greater than 10 μ F capacitance is recommended. Place this ceramic capacitor really close to the IN and GND pins to minimize the potential noise problem. Care should be taken to minimize the loop area formed by C_{IN} , IN and GND pins.

Output Capacitor C_{OUT}

The output capacitor is selected to handle the output ripple noise requirements. Both steady state ripple and transient requirements must be taken into consideration when selecting this capacitor. For the best performance, it is recommended to use an X5R or a better grade ceramic capacitor with 10V rating and greater than 10 μ F capacitance.

Output Inductor L

There are several considerations in choosing this inductor.

- 1) Choose the inductance to provide the desired ripple current. It is suggested to choose the ripple current to be about 40% of the maximum output current. The inductance is calculated as:

$$L = \frac{V_{OUT}(1 - V_{OUT}/V_{IN,MAX})}{F_{SW} \times I_{OUT,MAX} \times 40\%}$$

Where F_{SW} is the switching frequency and $I_{OUT,MAX}$ is the maximum load current.

The SY8032I is quite tolerant of different ripple current amplitude. Consequently, the final choice of inductance can be slightly off the calculation value without significantly impacting the performance.

- 2) The saturation current rating of the inductor must be selected to be greater than the peak inductor current under full load conditions.

$$I_{SAT, MIN} > I_{OUT, MAX} + \frac{V_{OUT}(1 - V_{OUT}/V_{IN,MAX})}{2 \cdot F_{SW} \cdot L}$$

- 3) The DCR of the inductor and the core loss at the switching frequency must be low enough to achieve the desired efficiency requirement. It is desirable to choose an inductor with $DCR < 30m\Omega$ to achieve good overall efficiency.

Load Transient Considerations

The SY8032I integrates the compensation components to achieve good stability and fast transient responses. In some applications, adding a ceramic capacitor (feed-forward capacitor, C_{ff}) in parallel with R_H may further speed up the load transient responses, and C_{ff} is recommended for applications with large load transient step requirements. Typically, for 1.2V/1.8V/3.3V output, the R_H , R_L , C_{ff} is recommended as below:

OCP and SCP Protection Method

With load current increasing, as soon as the high side FET current gets higher than the peak current limit threshold, the high side FET will turn off. If the load current continues to increase, the output voltage will

drop. When the output voltage falls below 50% of the regulation level, the output UVP will be detected and SY8032I will operate in hip-cup mode. The hip-cup frequency is 400Hz and the hip-cup duty cycle is 50%. If the hard short is removed, the IC will return to normal operation.

Layout Design

The layout design of the SY8032I is relatively simple. For the best efficiency and to minimize noise problems, we should place the following components close to the IC: C_{IN} , L, R_H and R_L .

- 1) It is desirable to maximize the PCB copper area connecting to GND pin to achieve the best thermal and noise performance. If the board space allows, a ground plane will be highly desirable.

- 2) C_{IN} must be close to pins IN and GND. The loop area formed by C_{IN} and GND must be minimized.
- 3) The PCB copper area associated with LX pin must be minimized to avoid the potential noise problem.
- 4) The components R_H and R_L and the trace connecting to the FB pin must NOT be adjacent to the LX net on the PCB layout to avoid the noise problem.
- 5) If the system chip interfacing with the EN pin has a high impedance state at shutdown mode and the IN pin is connected directly to a power source such as a Li-Ion battery, it is desirable to add a pull-down $1M\Omega$ resistor between the EN and GND pins to prevent the noise from falsely turning on the regulator at shutdown mode.

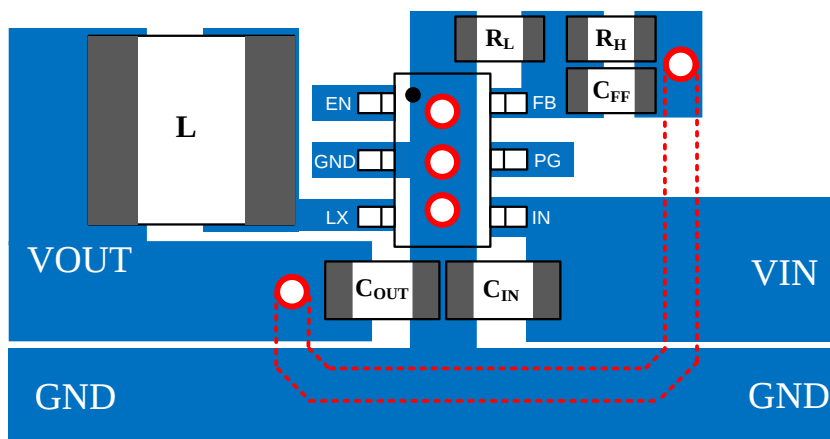
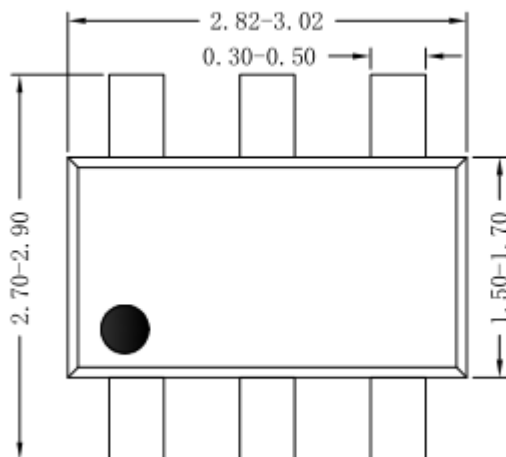
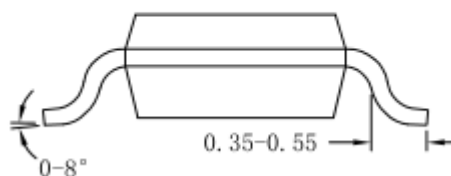


Figure4. PCB Layout Suggestion

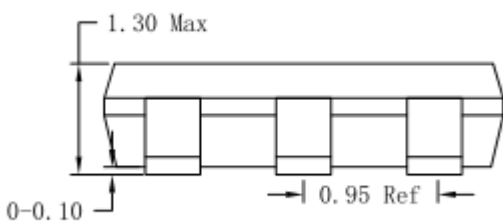
SOT23-6 Package Outline & PCB Layout Design



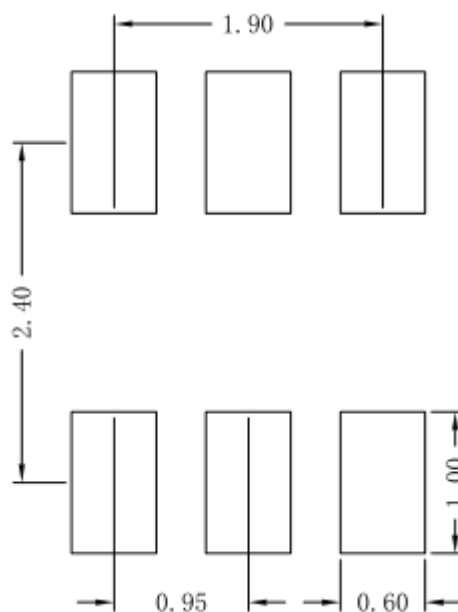
Top View

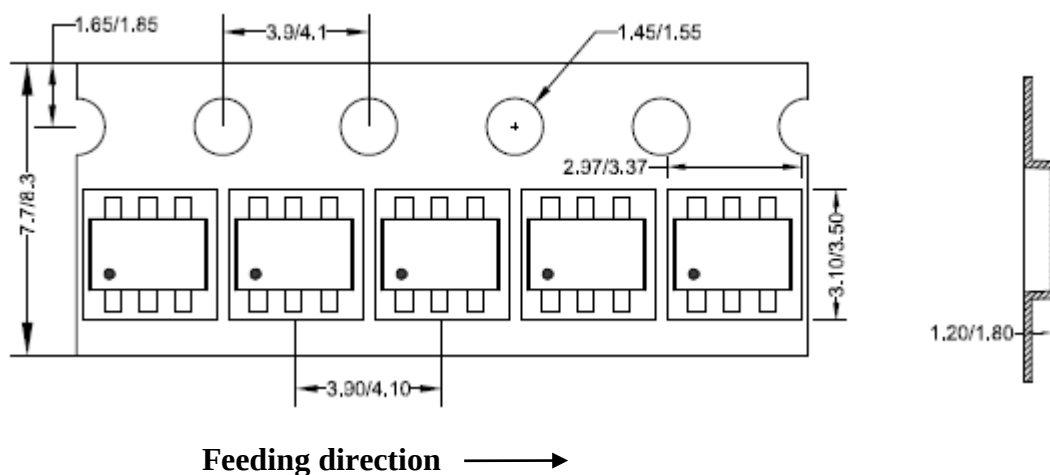


Recommended Pad Layout

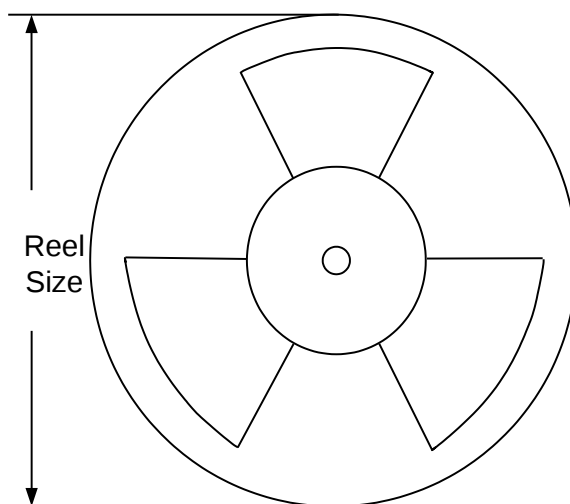
