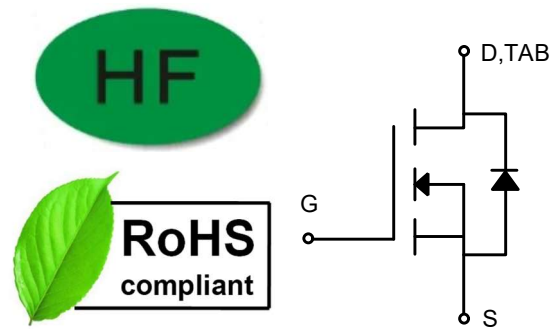
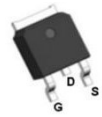

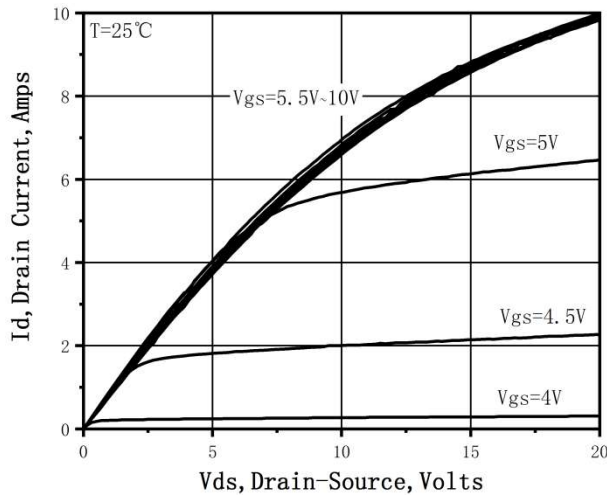


Figure 1. On-Region Characteristics

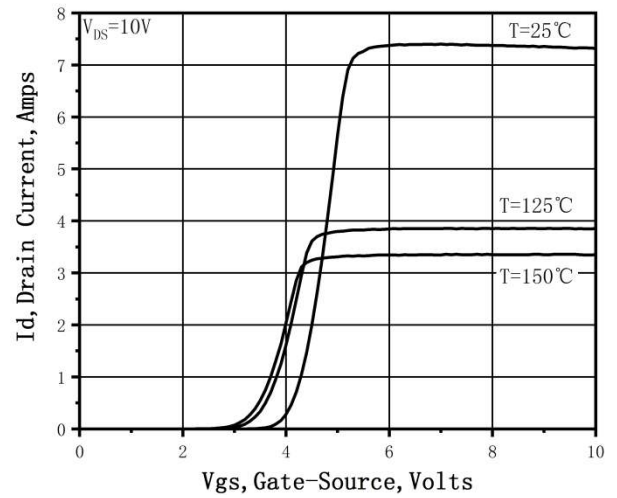


Figure 2. Transfer Characteristics

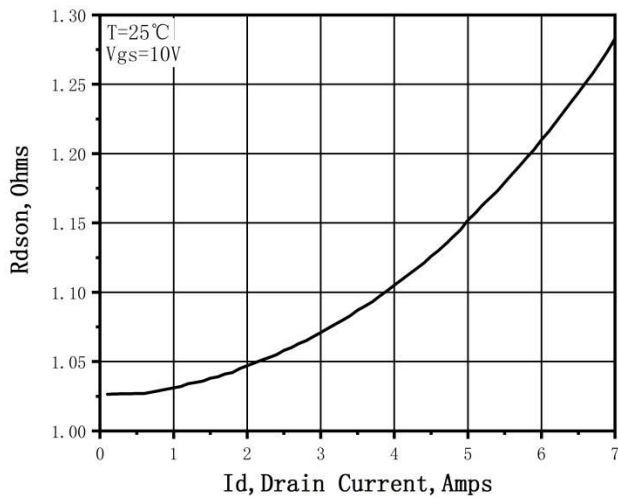


Figure 3. Static Drain-Source On Resistance

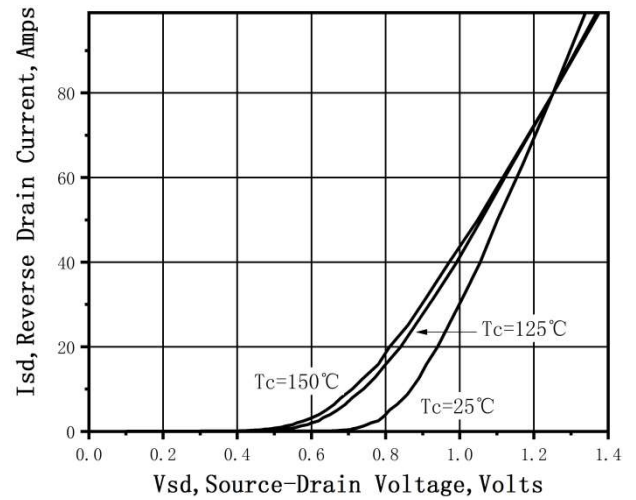
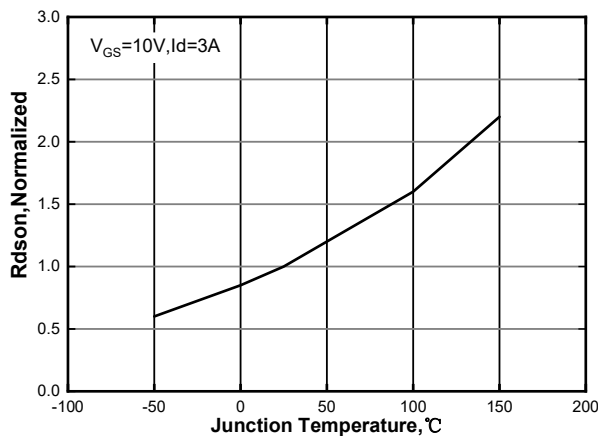
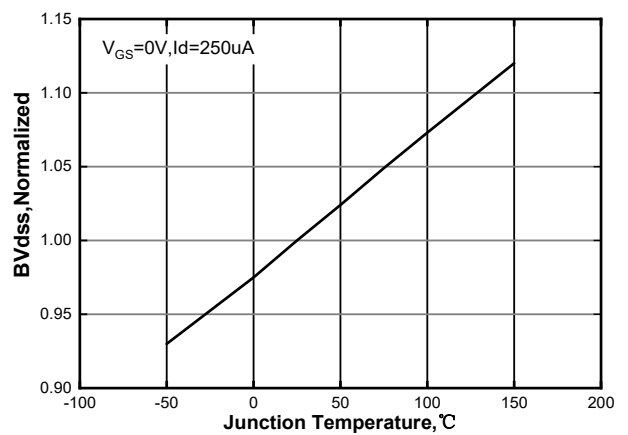


Figure 4. Typical Body Diode Transfer Characteristics

Figure 5. Normalized $R_{DS(on)}$ vs. TemperatureFigure 6. Normalized BV_{DSS} vs. Temperature

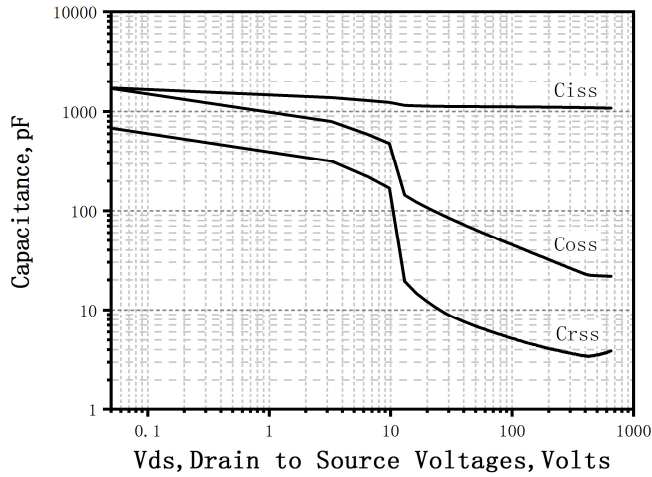


Figure 7. Capacitance Characteristics

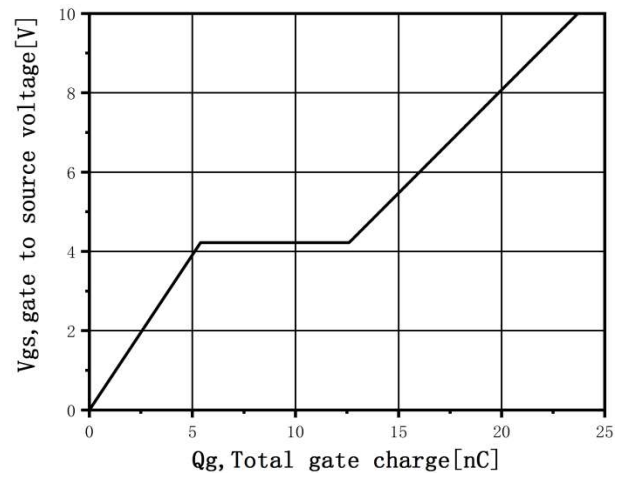
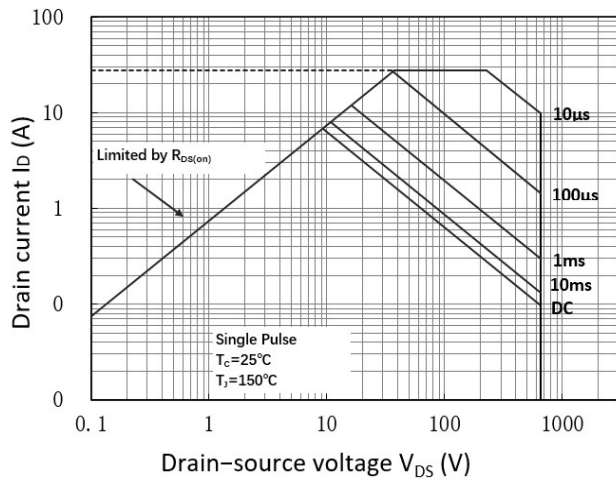
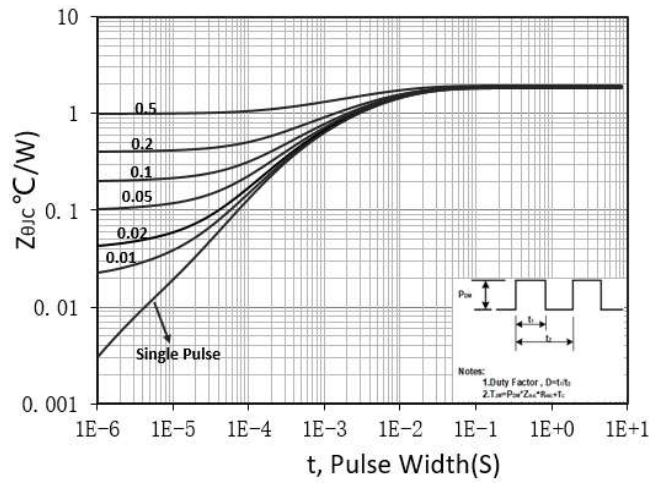
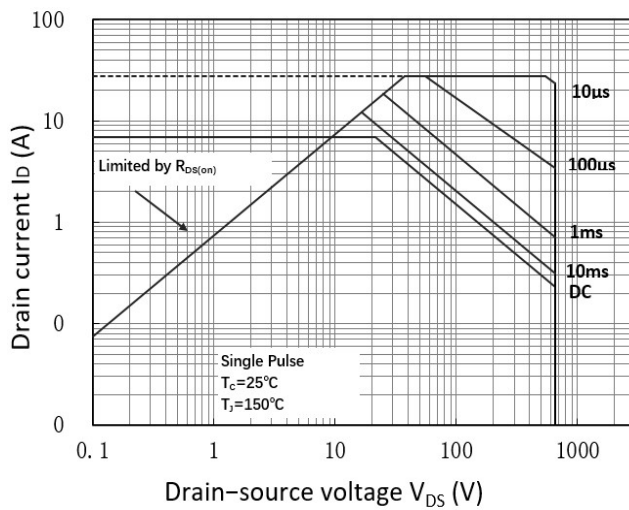
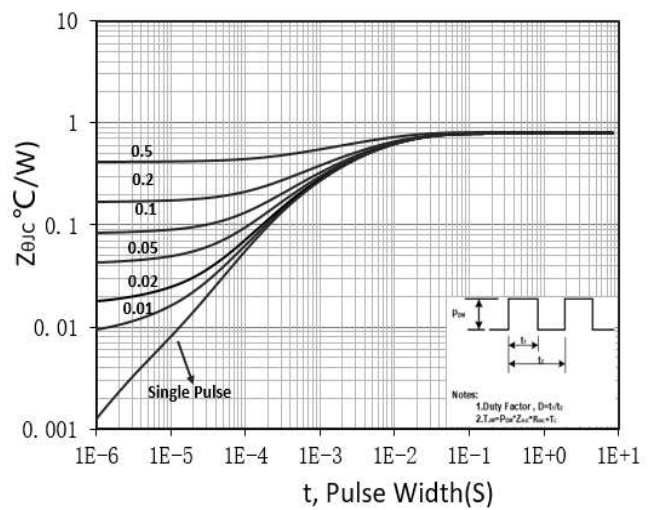


Figure 8. Gate Charge Characteristics

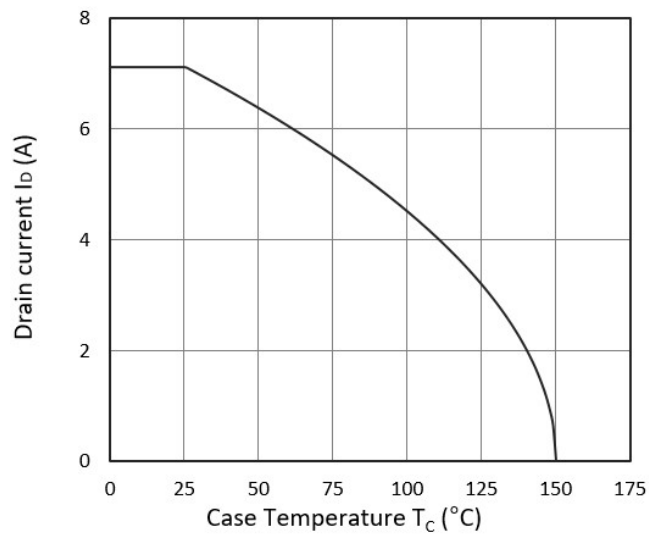
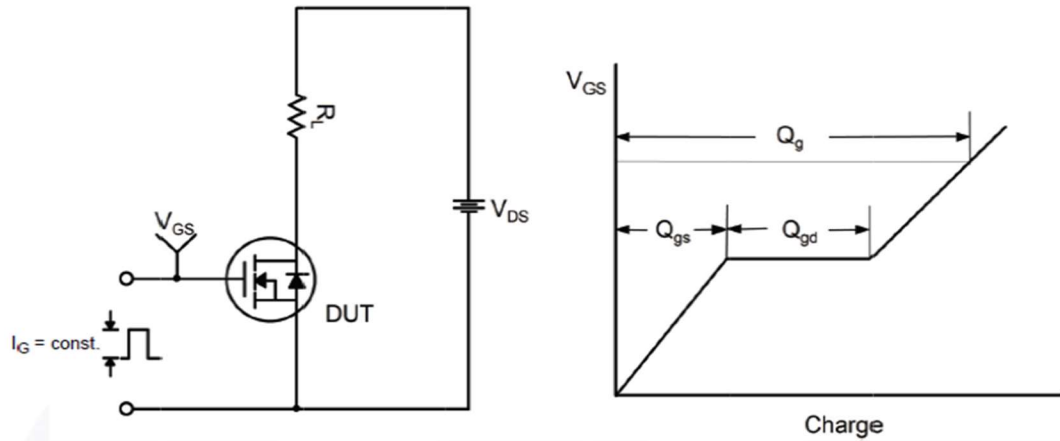


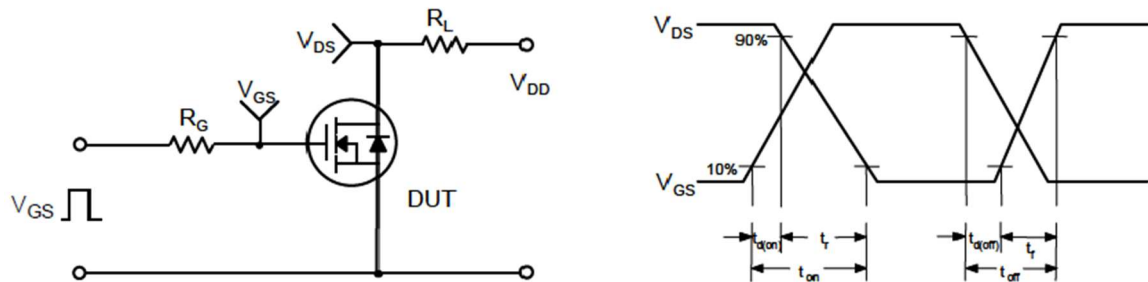
Figure 13. Drain Current vs. Temperature

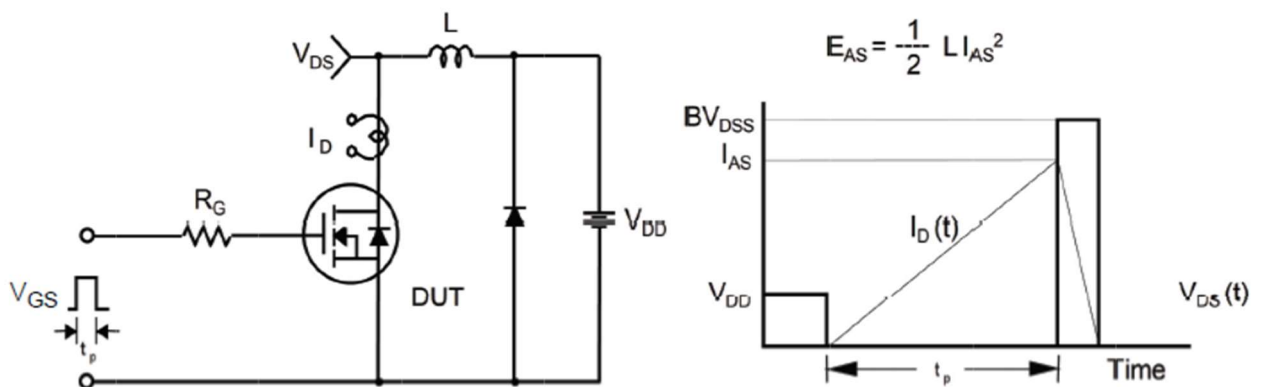
Gate Charge Test Circuit & Waveform



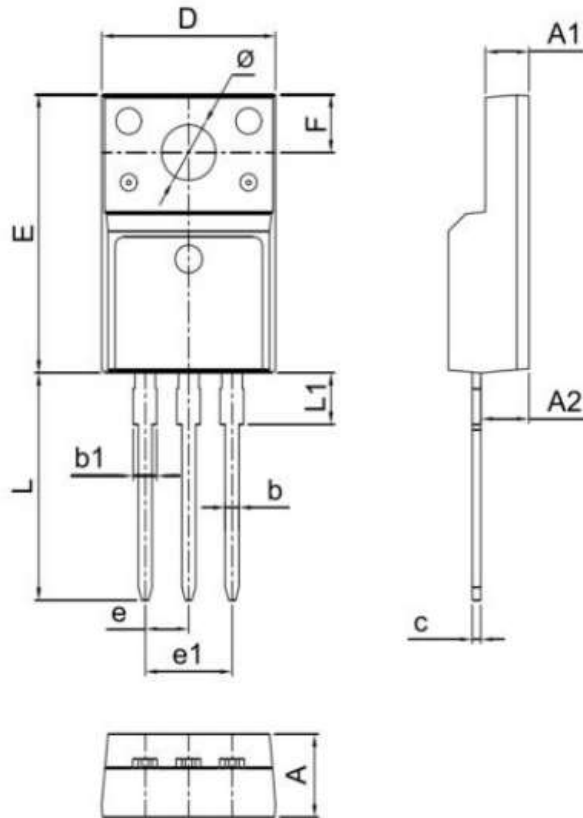
Switching Test Circuit & Waveforms



Unclamped Inductive Switching Test Circuit & Waveforms



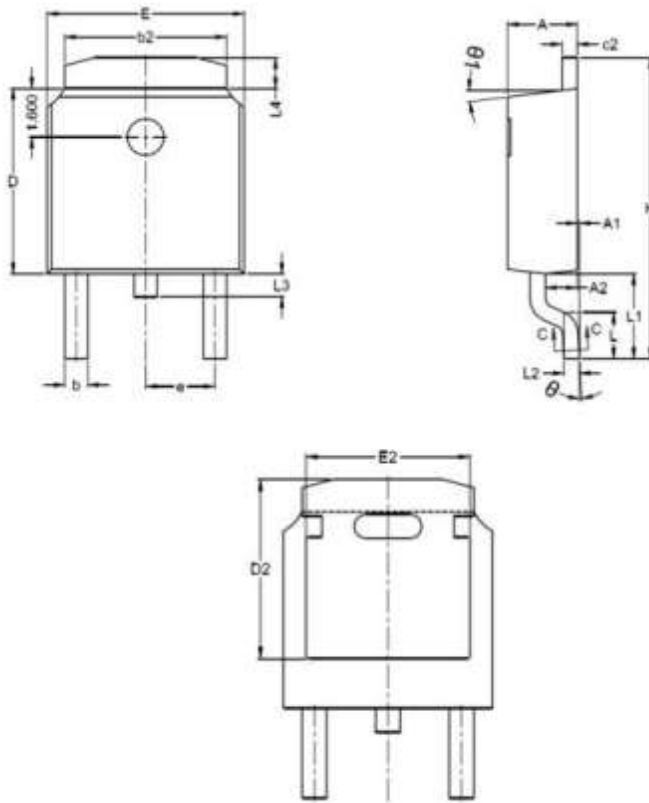
